Design & Specification of proposed Science Models & Exhibits also are to be framed by agency. The Design must be based on interactive experience with all the safety measures for the visitors to see & learn the concepts of Science Models & Exhibits in a protected manner.

- (ii) **Technical Specification:** Technical specification of all Science Models & Exhibits will be framed by the agency concerned.
- (iii) Supply & Installation of Science Models and Exhibits:-Supply, installation & commissioning of Science Models and Exhibits will be done by agency concerned.

### (iv) Operation& Maintenance

- (a). Regular maintenance and timely up keep of models& exhibits will be firm's responsibility for 02 years, which may be further extended.
- (b). Downtime for any model/exhibit should not be more than 03 days in continuous.
- (c). Firm will be solely responsible for the safety of the operators and other staff.
- (d). Associated accessories required, if any, to complete the above work would be arranged by the Firm at his /her own cost.
- (e). Firm shall arrange for transportation, loading and unloading and safe storage of material at site at his own cost.

## 9. OBLIGATION TO DIRECTORATE OF EDUCATION:

## 10. RESPONSIBILITY OF FIRM:
