ORDER

Cancellation of offer of Appointment and candidature to the post of TGT(ENGLISH) FEMALE, Post Code 51/21

Whereas, **Ms Tina Jaiveria, DoB 09.08.1987, Roll No. 113105100145, Category SC**, has been nominated by the DSSSB to the post of TGT (ENGLISH)-FEMALE against Post Code 51/21 vide Result Notice No. 1408 dated 20/07/2022 in the Directorate of Education, Govt. of NCT of Delhi and their e-dossiers received from DSSSB for further proceedings of appointment. During the Document verification, the DV Team has raised the following deficiencies in the deficiency memo dated 01.12.2022:

1. NCTE Certificate is not attached.
2. Father's Name mismatch in 10th, 12th and other documents.
3. Admit card first page not attached.
4. In Attestation form Point No.12 (a,b,c,d,e,f) marked as 'YES', therefore required full particulars of case and court decision.


In response to above deficiency memorandum, the candidate has submitted (1) NCTE Certificate (2) Affidavit duly attested by Executive Magistrate, Narnaul in respect of Father's Name (3) Affidavit and Copy of FIR in respect of lost Admit Card.

Ms Tina Jaiveria has also provided a copy of the court orders/judgement in respect of **Point No.4** regarding status of Court Case/Court order filed against her. **Ms Tina Javeria** was convicted by the Court of Hon'ble Additional Session Judge, Narnaul (Haryana) in the Case No. HRNR01-006047-2018, Dated of decision 16/11/2019. She was convicted under 306 of IPC.

The opinion of the Services Department was sought and further the LA, Education Department also examined the case of **Ms. Tina Jaiveria** and opined that "*case is under Section 306 of IPC which is in the category of heinous and serious offences as per the Hon'ble Supreme Court of India's judgement in Criminal Appeal bearing Crl. A.No. 1061-1084/2022 arising out of SLP (Crl.) No. 1132-1155 of 2022 titled as "Daxaben Vs State of Gujarat & Ors"*". Hence the candidate **Ms Tina Jaiveria** is not eligible to the post of TGT (English) Female, Post Code 51/21 as a court case under Section 306 of IPC is pending against the candidate.

Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Ms Tina Jaiveria, DoB 09.08.1987, Roll No. 113105100145, Category SC, post TGT (ENGLISH)-FEMALE, under post code 51/21** and return her dossier to the DSSSB.

This issues with the prior approval of the Competent Authority.
