CANCELLATION ORDER

Whereas, the candidate namely Mr. JADUMONI BHANDARI (D.O.B – 22.01.1991), Roll No. 112303500275, a candidate of 'UR' category under 'Waiting Panel' was nominated by the DSSSB for the post of TGT (Natural Science) -Male, post code - 35/21 (as per Vacancy Notice Advertisement No.02/21 dated 12.05.2021) by the Selection Mechanism Authority of DSSSB vide their Result Notice No 145 dated 28.07.2022 and his e-dossier was forwarded to the Department for further proceedings towards consideration for appointment for the aforesaid Post.

And whereas, a 'Memorandum towards Offer of Appointment' was issued on 26.07.2023 to the aforesaid candidate after preliminary scrutiny of documents available in e-dossier with the directions to appear in person on the scheduled date, time and venue along with all the required requisite documents for verification as per prevailing Rules/ Guidelines.

And whereas, **Mr. JADUMONI BHANDARI** did not report/appear on the scheduled Venue, Date & Time given in the 'Offer of Appointment' issued to the aforesaid candidate vide letter number F.No.DE.3(29)/DRC/E-III/TGT/NATURAL SCIENCE(MALE)/2022/68078 dated 26.07.2023 and further subsequent Reminder/ Reminders issued vide letter of even number dated **21.08.2023**, dated **06.09.2023** and IIIrd reminder dated **03.10.2023** as Final Reminder, however, the aforesaid candidate did not appear in person before "Documents Verification Team".

And whereas, further a "Final Opportunity" through a Memorandum dated 23.02.2024 was also given to the aforesaid candidate on the basis of his written request dated 09.10.2023 (received on 17.10.2023) after the approval of competent authority and accordingly the aforesaid candidate was directed to appear in person on 05.03.2024 at scheduled time and venue alongwith required requisite documents for verification, however, he again failed to appear before documents verification team on scheduled date, time and venue. Further, neither he has intimated till date any reason to this Directorate towards not reporting/appearing before DV Team nor has yet represented himself through any mode of communication.

Therefore, in view of the above facts & circumstances as stated above and since the Candidate has willfully chosen not to respond to the Memorandum/Offer of Appointment and this tantamount to refusal to accept 'Offer of Appointment'. Therefore, the candidature of **Mr. JADUMONI BHANDARI**, Roll No – 112303500275, an 'UR' candidate, is hereby cancelled/rejected.

"No claim for Appointment, if so, made at any later stage on the basis of any ground by the Candidate will be entertained by the Department, in future."
