Governor hereby declares—State Council of Educational Research and Training, Delhi (SCERT) as the "Academic Authority" for the purposes of Section 29 of the Right of Children to Free and Compulsory Education Act, 2009 and rule 21 of the Delhi Right of Children to Free and Compulsory Education Rules, 2011.
