CIRCULAR

In connection with the ongoing work of distribution/delivery of the Free supply of the Textbooks of 1st Standard to 8th Standard under Samagra Shiksha-Delhi for the academic year 2024-25, in all Govt. Schools (DoE, MCD, NDMC,DCB), a Circular No.DE 29(5)(36)/SS/Textbook I-VIII/2023-24/168-180, dated 16.04.2024 (Copy enclosed) has been issued by Samagra Shiksha-Delhi. Now it has been decided that the Textbooks, provided at schools level, need to be verified on daily basis. For verification of Textbooks, CRCCs role is very important, as each CRCC has to complete the Verification of Textbooks received by HoS in his/her cluster on daily basis and furnish the Verification Report to DURCC on next day itself. Each DURCC has also to conduct verification of Textbooks received in atleast 5 schools in each District on weekly basis. DURCC has to furnish one Single Report of verification of Textbooks received for a period of seven days (Weekly Report) to State Project Director, Samagra Shiksha-Delhi through mail as well as signed printed copies, along with the daily reports of verification done by CRCCs till the distribution of Textbooks is completed.
