**Sub:- Operationalization, regular repair and maintenance of the swimming pools of this Directorate.**

Sir,

This Directorate owns the swimming pools in the following 17 schools of Directorate of Education.

1. Shaheed Amir Chand Sarvodaya Vidyalaya, Sham Nath Marg Delhi.
2. GBSSS, Bharat Nagar, Delhi.
3. RSBV, Jheel Khuranja, Delhi.
4. Babu Ram SBV, Bhola Nath Nagar, Shahdara, Delhi-
5. GBSSS, Sector VI, R.K. Puram, New Delhi.
6. GBSSS No.1, Rajouri Garden Extn., New Delhi.
7. Asharfi Devi SBV, Plot No.6, Jhandewalan, New Delhi.
8. SBV, West Patel Nagar, New Delhi.
9. SKV No.2, C Block, Janakpuri, New Delhi.
10. SKV L Block, Hari Nagar, New Delhi.
11. GBSSS, A Block, Defence Colony, New Delhi.
12. SBV No.1, Shakurpur, Delhi-34.
13. Sarvodaya Co-ed. Sr. Sec. School, Safdarjung Enclave, New Delhi.

Every year, the swimming pools are put in operation from 1<sup>st</sup> April and continuing upto 15<sup>th</sup> November. The operation of the swimming pool and filtration plant etc. is undertaken by the Electrical division of their area whereas the normal repair and maintenance of deck area, maintenance of bath rooms & change rooms is undertaken by the civil division of that area.

Besides above, the following swimming pools have been constructed and likely to be handed over to this office:-

1. SKV, Pkt-B, Mayur Vihar Phase-II, Delhi
2. Rajkiya Sarvodaya Kanya Vidyalaya, West Vinod Nagar, Delhi.

The concerned heads of schools have to apply for obtaining license for the swimming pools from Delhi Police but before applying for the license, PWD has to provide a couple of

certificates with regard to water testing report, electrical installation report etc. for ensuring safety concerns of the students.

Hence, it is requested that the civil & electrical divisions of the concerned swimming pools in the above stated Govt. schools may be requested to undertake necessary works and prepare the swimming pools by **1<sup>st</sup> March 2018** positively so that the concerned heads of the schools may collect the necessary documents e.g. water testing report, electrical installation report etc. so that the heads of the schools may apply for license to Delhi Police for starting the swimming pools w.e.f. 01.04.2018 for the summer season.
