## Scope of the work are given as under:-

- 1. Vendor will have to install hydroponic system in each school at their own expenses. No extra payment will be given on any account. Complete set up and its produce will be property of the Samagra Shiksha-Delhi.
- 2. Vendor will have to arrange resource person for each work shop at the school level.
- Performance guarantee @ 3% of the total amount will have to deposit in the office of Samagra Shiksha in name of State Project Director, Samagra Shiksha-Delhi by the Vendor in form of DD/banker cheque/Bank Guarantee valid for a period of three months.
- 4. List of the school will be provided to the Successful bidder with the work order.
- After the each workshop a feedback form along with attendance sheet of gathering, duly signed by DURCC/CRCC/Incharge will be submitted to this office.
- 6. No amount will be paid as advance to the successful Bidder.
- 7. Penalty will be levied @ Rs 1,000/- per day if the workshop is not organised without prior approval.

## **Eligibility Criteria**

- 1. The bidder will have to submit experience of the work in same field of atleast 03 years.
- 2. The Bidder will have to submit the workshop scheme in summary with the quotation (preferably in three Pages). Only bidder(s) whose presentation qualifies the scrutiny by the Purchase Committee and Quality Evaluation Committee will be considered for financial evaluation. The decision of the Committee will be final.
- 3. An affidavit to the effect that their firm/agency/NGO has not been blacklisted by any Govt./Authority/Department executed on stamp paper duly attested.
- 4. Bidder will have to submit registration document of their firm/agency/NGO etc.
- 5. The Bidder/Authorized signatory should submit all the tender document duly signed on each page as a token of acceptance of terms and conditions of the tender.
