The verification of educational document may also be got done through their issuing authority and an undertaking may also be obtained from Guest Teacher concern to this effect that his/her deployment is subject to verification/authentication of document and he/she will be liable to be initiated action against his/her, in case it is found that the document submitted by him/her are not genuine as per record.
