- 6. Identity Proof (preferably Copy of Aadhar card).

Candidates without certificate, degree or provisional will not be entertained. Mere allotment of school does not ensure the engagement of the candidates; it is further subject to the availability of vacancy at the time of reporting in the allotted school and fulfilment of eligibility criteria as per existing RRs of DoE.

Further, Concerned HOS will take following action/instructions for the engagement of Special Education Teachers (Guest) for session 2018-19;

- 1. Issue manual joining to Special Education Teacher (Guest) if the teacher fulfils all eligibility condition for his/her particular posts/subjects laid by DOE as per existing RR's for Special Education Teacher.
- 2. NO separate individual order will be issued to each candidate for joining and NO candidates should be send to Inclusive Education Branch, Lajpat Nagar-IV or office of DDE (District) concerned for joining related matter. Necessary online link at school level shall be provided shortly for generating online engagement letter.
- 3. Spelling of name in application form, certificate, Aadhar Card should be same to avoid discrepancies during salary generation.
- 4. Verify the age, qualification, result, marks sheet of the concerned candidate.

- 5. Submit a copy of manual joining immediately in the Inclusive Education Branch, Directorate of Education, GNCT of Delhi, Amrita Shergil School Bldg, Behind Lady Sri Ram College, Lajpat Nagar-IV, New Delhi-110024 under intimation to DDE (District) concerned so that his/her name may be uploaded in MIS for online joining.
- 6. Thereafter, HOS may check the candidate's name in MIS and generate online engagement letter.
