With reference to the public notices cited above, and circular No.F.05/DDE(IEB)/SS/ResourcePerson/2019/9001-9006 dated 01/11/2019 and subsequent corrigendum No.F.05/DDE(IEB)/SS/ResourcePerson/2019/9084-9089 dated 06/11/2019, all the provisionally eligible candidates, under Category A, who have completed their document verification on 13/11/2019 for engagement as Resource Persons (CWSN) on contractual basis under Samagra Shiksha, Delhi for 2019-20, are now directed to appear for the interview/skill test as per details below:

Instructions to candidates

1. The list of provisionally eligible candidates are given in **Annexure – I** along with the **schedule for interview/skill test i.e., from 22nd & 23rd November 2019.**
2. These candidates are directed to report interview/skill test as per schedule mentioned against their name **at the Inclusive Education Branch (IEB), Directorate of Education GNCTD, Behind Lady Sri Ram College, Lajpat Nagar-IV, New Delhi-110024** along with following documents:
 - a. Signed copy of online application filled by candidate for 2019-20.
 - b. All original certificate along with their original mark sheet and certificate of 10th, 12th, Graduation and B.Ed in Special Education or its equivalent for Category 'A'.
 - c. CTET (Original) certificate (Paper-II)
 - d. RCI registration certificate
 - e. Experience certificate issued by concerned HOS and countersigned by the concerned DPO/Zonal Deputy Director of Education/Education Officer. **The experience certificates without the counter sign of the concerned district/zonal authorities will not be considered for**

finalizing the merits. After interview no additional opportunity shall be given for submission of countersigned experience certificate.

- f. SC/ST/OBC Caste certificate (if claiming benefits of reservation). In case of candidates belonging to OBC, the OBC certificate should be issued by Govt. of NCT Delhi.
 - g. If any eligible candidate seeks benefit under EWS category, he/she has to produce the certificate issued by the competent authority.
 - h. Affidavit regarding creamy layer (for OBC candidates only)
 - i. Proof of present & permanent address
 - j. Certificate of disability issued by the competent authority (if applied in the category of Persons with Disabilities)
 - k. Two recent passport size photographs (one should be self attested)
 - l. Photo Identity Card (Preferably Aadhar Card)
3. The final merit list shall be prepared on the basis of weightage of marks/marking scheme notified vide circular vide No.F.05/DDE(IEB)/SS/Resource Person/2019/7898-7903 dated 06.09.2019.
4. Further, as per the document verification held in two phases, **few candidates have not produced all documents for verification**. All such candidates as per **Annexure – II** are directed to produce the same for verification **on the day of interview**, failing which their candidature shall be liable to be cancelled.
5. No TA/DA shall be provided to any candidate for attending the interview.

This is in addition to the list of candidates called for interview/skill test vide public notice No.F.05/DDE(IEB)/SS/Resource Person/2019/9007-9012 dated 01/11/2019. **In case the applicant/candidate does not appear for interview/skill test, no request will be entertained thereafter under any circumstances.** Mere attending interview/skill test does not guarantee the engagement as Resource Person (CWSN), which is further subject to availability of vacancies and fulfilment of eligibility as mentioned in Public Notice dated 26/06/2019.


