### ENGAGEMENT OF GUEST TEACHER Out of Panel 2017-18 For 2018-19(List-03)

Reference with base circular no F.DE.18.2(15)/E-V/2017/199 dated 26.05.17, regarding subject Drawing a panel of guest teachers for engagement in Delhi Government Schools for the Academic Year 2017-18 and subsequent circular Nos. F.DE.18.2 (15)/E-V/2017/587-590 dated 19.09.17 and F.DE.18.2(15)/E-V/2017/591-595 dated 20.09.17, schedule for verification of documents for engagement as guest teacher was displayed and verification of reported candidates have been done in the district office accordingly.

Further, reference Circular no. F.DE.18.2 (16)/E-V/2018-19/508-513 Dated:-27/06/2018 regarding Subject:-Re-engagement of Guest Teachers for the Academic Session 2018-19. Disengaged Guest teachers of District North West-B have been Re-engaged against Vacant posts /Subjects accordingly. Due to requirement of Guest teachers against Existing vacant posts in the schools of District North West-B, Guest teachers from the Panel 2017-18 have been allotted schools for some posts/subjects.

For some post/subject, there are vacancies in Boys only school but no male candidate is available but female candidates are available and no vacancy in Girls/Co-ed schools. Therefore, Female candidates also have been allotted boys only schools. Such female candidates, if not interested to join in boys only school, may submit their unwillingness in the district office immediately.

Guest teachers who have been allotted schools are hereby informed to report for joining in the office of concerned HOS within next three working days and submit the manual joining in the district office. At the time of report concerned guest teachers must carry following documents for verification by the concerned HOS-

- 1. Copy of online Registration slip/Application Form 2017-18
- 2. SC/ST/OBC/PH caste certificate (if applicable).
- 3. Self attested photocopies of all relevant educational qualifications (both sides) like year wise Mark sheets/Certificates, Provisional/Degree (from 10<sup>th</sup> onwards). Candidates without certificate. degree or provisional will not be entertained.
- 4. CTET marksheet and certificate (if applicable).
- 5. One photograph pasted on the Application form (Not stapled)
- 6. Identity Proof (preferably Copy of Aadhar card).
- 7. Affidavit regarding authenticity of documents produced at the time of report in school.(Sample for Affidavit is Enclosed.

Further, concerned HOS will take following action for the engagement of Guest Teacher for session 2017-18:

- 1. Give the concerned Guest Teachers manual joining if the teacher fulfils all eligibility condition for his/her particular posts/subjects laid by DOE as per existing RRs.
- 2. Submit a copy of manual joining immediately in the o/o OSD (NW-B) so as his /her name can be uploaded in MIS for online joining.
- 3. Thereafter HOS may check the candidate name in MIS and generate online engagement letter.
- 4. Obtain Original Affidavit from Candidate regarding Authenticity of documents.

Mere allotment of school does not guarantee the engagement of the candidate; it is further subject to the availability of vacancy at the time of reporting in the allotted school and fulfillment of eligibility criteria as per existing RR.s of DOE.

After joining of eligible candidates HOS must get their documents verified from their respective boards/institution/universities. Further in case any negative report, immediately inform District office.
