- b. CTET qualification certificate.
- c. All original certificates along with their original year wise mark sheets and certificates of 10th, 12th, ETE/JBT/B.El.Ed. or equivalent.
- d. SC/ST/OBC Certificate (if applicable).
- e. Certificate of disability issued by the appropriate authority (if applied in PH category).
- f. Two photographs (one attested)
- g. Photo Identity card (preferably Aadhar Card)
- h. The candidates shall also furnish one attested set of the above documents.

Note:-

- 1. The certificate of OBC should be issued by Authorities of Govt. of NCT of Delhi. For SC/ST candidates, Certificates from other state can be considered. For PH category, requisite certificate from competent authority be submitted.
- 2. The candidature of all the applicants who have filled wrong entries in the online application shall be rejected even if they are found in merit list.
- 3. The Candidate who fails to appear on the scheduled date and time shall not be allowed to submit documents for verification subsequently.
