Sub:-Fancy Dress Competition for Primary Level – Theme Eminent Personalities belonging to SC/ST & Minority community under Samagra Shiksha

The Project Approval Board (PAB)-2019-20 of MHRD, Govt. of India for Samagra Shiksha Abhiyan (SS) has approved a sum of **Rs.12.24 Lakh** for Fancy Dress Competition for primary students of government schools, in the SC/ST/Minority Community (Elementary) activity under Minor Component 'Special Projects for Equity' of Major Component 'Gender & Equity' for the year 2019-20, as per U-DISE data 2017-18.

The fancy dress competition will be based on the theme- Eminent personalities belonging to SC/ST & minority communities who have made significant contributions in various fields. This way children will learn to appreciate that talent, caliber and intelligence know no caste, creed and colour.

60 students will participate at cluster level. Prize will be distributed to the winners at cluster level.

The details of proposed activity- Fancy Dress competition for primary students from Government Schools, are as under-

Activity- Fancy dress competition Programme

Implementation Level- Cluster level, total 136 clusters

Target Group- 60 students of Class I-V (Primary students) per cluster, so $60 \times 136 = 8160$

Amount- Rs 9000/- per cluster, so $9000 \times 136 = \text{Rs.12,24,000 /-}$

Objective- The aim is to familiarize students with the contributions made by eminent personalities hailing from SC/ST & Minority community and their being role models for the young generation of learners.

Guidelines for the Fancy Dress Competition Activity

- a. The amount given to concerned DDEs/DPOs under "Gender & Equity" Special Projects for Equity (Elementary) is for conducting Fancy dress competition for primary students from Government Schools @ Rs 9000/- per cluster
- b. The Activity will be conducted at Cluster Level in all Districts
- c. 60 students of Class I-V (Primary students) from one Cluster will participate.
- d. Activity should be held during the school hours.
- e. The theme of the Fancy Dress Competition is- Eminent personalities hailing from SC/ST & Minority community
- f. The Judges for this activity can be HoS/teachers of neighbouring schools belonging to the SC/ST & Minority community. This can be a way of honouring them for their contribution in furthering the inclusion of their communities in the mainstream society.
- g. While addressing the students, these HoS/teachers can also share their own success stories and thus be role models for the children.
- h. The fund will be released as an advance to the HoS of the venue and settlement of the advance alongwith Utilization Certificate should be submitted within two weeks from the date of the completion of the activity.
- i. The DURCCs of the respective district will prepare the detailed report along with the photographs and video shoot and submit at the HQ in spiral binding (Album form).

- j. Feedback forms have been developed for the judges, HoS, Teachers & CRCCs to get their inputs regarding the activity.
- k. The compiled feedback report, district wise to be forwarded to SS-HQ within two weeks of completion of the activity.
- l. The Nodal Officer for the activity should compile the feedback forms, MCD forms from all districts and submit the same to SS-HQ.




