PUBLIC NOTICE

Sub: - Re-deployment of Guest Teachers (ASSISTANT TEACHER PRIMARY) for the academic year 2020-21, District North-East-II.

In pursuance of **Circular No. F. DE. 18.2(15)/E-V/2017/part/667-671 dated. 01/10/2020**, regarding re-deployment of Guest Teacher for the academic year 2020-21 DDE Districts were asked to re-deploy Guest Teachers who have been relieved due to PFC/ Promotion of regular teachers/ joining of fresh recruits/transfers etc. during previous academic session on priority basis against available vacancies in the Govt. schools. Schools have been allotted to those relieved eligible candidates who had approached in the office of DDE North-East-II and submitted their representations up to 26/12/2020 and vacancy statement as on 26/12/2020 requesting for their re-deployment. Allotment of schools has been done on the basis of vacancies taken from MIS module.

Guest Teachers who have been allotted schools are hereby informed to report for joining in the office of concerned HOS within next three working days. Mere allotment of school does not ensure the engagement of the candidate; it is further subject to the availability of vacancy at the time of reporting in the allotted school. At the time of reporting, concerned teacher must carry following documents for verification by the concerned HOS.

- Copy of online Application Form
- Copies of online or offline generated experience certificate along with relieving order duly signed by concerned HOS.
- Self attested photocopies of all relevant educational qualifications i.e. year wise Mark sheets/Certificates, Provisional/Degree (from 10" onwards). Candidates without certificate, degree or provisional certificate will not be entertained.
- One photograph pasted on the Application form (Not stapled)
- Identity Proof (preferably Copy of Aadhar card).

Further, concerned HOS will Give manual joining to the Guest Teachers if the teacher fulfills all eligibility condition for the particular post/ subject laid down by DOE as per existing RRs and a copy of the same will be sent to DDE Office after joining of all teachers in the schools Immediately.


No verification of documents is done at district level. Therefore, the HOS concerned shall verify the certificate of CTET along with other educational qualification certificates, and also ensure that the Guest Teachers fulfils the RRs applicable to the post allocated to them, before generating the joining report. The HOS concerned shall be responsible for any negligence committed in verification of documents and fulfillment of RRs by the guest teacher. In case any Guest Teachers does not turn up for joining the same shall be reported to the District Office Immediately. For any query regarding engagement of Guest Teachers HOSs may contact guest teacher branch.

In some cases Female candidates have been allotted second shift school. In such cases an undertaking/willingness from both HOS & candidate is required that they don't have any objection to join second shift school and they shall not request for transfer in future as per term and condition of engagement letter of guest teachers.

Allotment of school does not guarantee the engagement of the candidate: it is further subject to the availability of vacancy at the time of report in the allotted school and fulfillment of eligibility criteria as per existing RR.s of DOE




