

1. HOS shall ensure that the Helper/Attendant should perform the duties exclusively for Children with Disabilities as per order No. 59/DDE(IEB)/Admn. Cell/SS/2019/1727-1733 dated 24.06.2020.
2. DPO/HOS concerned shall take their services in implementation of Home Based Education to Children with Disabilities in addition to their day to day duties.
3. The District Coordinator (IE) must monitor the duties of Aaya/Attendant/Helper.
4. DPO/HOS shall release remuneration @15908/- per month on the time to the Aaya/Attendant/Helper for the year 2022-23.
5. The HOS/RCC shall submit an appraisal report in respect of duties performed by each attendant/helper separately to concerned DDE (District) in second week of March 2023.



2. The engagement will be purely contractual in nature and will not confer upon him/her any right whatsoever for regular appointment or placement in any other Deptt. under the Govt. of NCT of Delhi.
3. The term of the engagement shall be from.....to .....
4. The Attendant/Helper/Ayah will be entitled to one day leave in each complete month which cannot be carried forward.
5. The Attendant/Helper/Ayah shall perform the services diligently and honestly. The Attendant/Helper/Ayah shall devote his/her full time, attention and efforts exclusively to the work assigned to him/her by the HoS as per order No.F.59/DDE(IEB)/Admn.Cell/SS/2019/1727-33 dated 24/06/2020.
6. The person shall not be entitled to any benefit to which the regular employees are entitled.
7. The post offered to him/her is non- pensionable and no other benefits are payable/ available to him/her for the period of service rendered in the school.
8. The contractual engagement is liable to be terminated at any time without any notice and without assigning any reason.
9. He/she shall serve a notice of one month before resigning from his/her post or deposit one month salary for immediate termination of contract.
