## **PUBLIC NOTICE**

**Sub: Verification of documents of candidates applied for engagement as Resource Persons (CWSN) on contractual basis under Samagra Shiksha, Delhi for 2022-23.**

This is with reference to the public notice No.F.211/DDE(IEB)/Admn.Cell/2022/7600-7606 dated 20/10/2022 vide which applications were invited for engagement of 17 Resource Persons (CWSN) on contractual basis under Samagra Shiksha for 2022-23 and public notice No.F.211/DDE(IEB)/Admn.Cell/2022/12294-12300 dated 09.12.2022 vide which the tentative merit list of candidates who have applied for engagement as Resource Persons (CWSN) was notified.


### **Instructions to candidates**

1. From the tentative merit list notified No.F.211/DDE(IEB)/Admn.Cell/2022/12294-12300 dated 09.12.2022 at the first round, 51 candidates from Category A have been called for document verification. The list of such candidates is given in **Annexure – I** along with the **schedule for document verification i.e., on 19<sup>th</sup> & 20<sup>th</sup> December 2022.**
2. These candidates are directed to report for verification of documents as per schedule mentioned against their name **at the Inclusive Education Branch (IEB), Directorate of Education GNCTD, Behind Lady Sri Ram College, Lajpat Nagar-IV, New Delhi-110024** along with following documents:
  - a. Signed copy of online application filled by candidate for 2022-23.
  - b. All original certificate along with their original mark sheet and certificate of 10<sup>th</sup>, 12<sup>th</sup>, Graduation and B.Ed in Special Education or its equivalent for Category 'A'.
  - c. CTET (Original) certificate (Paper-II)
  - d. RCI registration certificate
  - e. Experience certificate issued by concerned HOS and countersigned by the concerned DPO/Zonal Deputy Director of Education/Education Officer.
  - f. SC/ST/OBC Caste certificate (if claiming benefits of reservation). In case of candidates belonging to EWS, OBC, the OBC certificate should be issued by Govt. of NCT Delhi.
  - g. Affidavit regarding creamy layer (for OBC candidates only)
  - h. Proof of present & permanent address

- i. Certificate of disability issued by the competent authority (if applied in the category of Persons with Disabilities)
  - j. Two recent passport size photographs (one should be self attested)
  - k. Photo Identity Card (Preferably Aadhar Card)
  - l. The Candidates shall also furnish one self-attested set of the all documents mentioned above.
3. **From Category A, the candidates whose name is not mentioned for document verification in Annexure – I shall be called for verification in the second round if required. The schedule for second round verification shall be notified in due course.**
4. **As mentioned in public notice No.F.211/DDE(IEB)/ Admn.Cell/2022/7600-7606 dated 20/10/2022, candidates belonging to Category B shall be called for document verification only if sufficient number of eligible candidates are not available in Category A for filling the vacancy.**
5. The final merit list shall be prepared on the basis of weightage of marks/marking scheme notified vide circular vide No.F.211/DDE(IEB)/ Admn.Cell/2022/7600-7606 dated 20/10/2022.
6. The selected candidates will be given offer of engagement based on the availability of vacant post.

***In case the applicant/candidate does not appear for verification of document, no request will be entertained thereafter under any circumstances.*** Mere verification of documents does not guarantee the engagement as Resource Person (CWSN), which is further subject to availability of vacancies and fulfilment of eligibility as mentioned in Public Notice dated 20/10/2022.
