





ANNEXURE-I

General Guidelines for Organization of Camps for distribution of Aids & Appliances to CWSN (Pre-school to Class XII) for 2021-22

1. The 12 camps will be organized for distribution of Aids and Appliances to recommended Children with Disabilities (Pre-school to Class XII) of Govt., Govt. Aided, Local Body and Local Body Aided Schools of Delhi for the year 2021-22
2. The distribution camp is for the following categories of Children with Disabilities: Locomotor Impairment, Hearing Impairment, Cerebral Palsy, and Multiple Disability as recommended during the assessment camps for the year 2021-22
3. The Distribution camps should be organized between 8:00 AM to 5:00 PM.
4. The HOS of the concerned schools where the said program is being organized are hereby directed to organize the same by keeping in view the social distancing norms issued by MHA, Gol due to prevailing COVID-19 conditions.
5. The District Coordinators (IE), TGT/PGT Special Education Teachers, and Resource Person (CWSN) shall work together in organizing Distribution Camp.
6. The District Coordinators (IE) shall ensure the participation of Children with Disabilities from Govt., Govt. Aided, Local Body & Local Body Aided schools. Nodal Resource Person (CWSN) shall facilitate participation of Children with Disabilities from Local Body & Local Body Aided schools.
7. Advance intimation to concerned parents for receiving the aids & appliances along with the child with disability must be conveyed through school.
8. DPOs/DDEs (District) shall ensure the advance arrangements / preparatory arrangements for organizing camps and distribution of Aids and Appliances to respective Children with Disabilities.
9. HOS of the schools where the Children with Disabilities, for whom the Aids and Appliances are recommended, are studying are directed to ensure that the same is collected during the camp.
10. HOS of venue shall ensure that resources/infrastructure available at the venue including sitting arrangement; public utility etc. shall be as per the norms of social distancing.
11. Thermal scanning of Teachers and Students shall be done at the entry gate itself. Sanitizers shall be made available for use by the participants by the concerned school.
12. District Coordinator (IE) shall submit a report of Distribution camp organized along with 05 to 10 photographs to this office within one week of completion of the camp.




