

The above mentioned candidates are directed to report to the HOS of the school mentioned against his/her name within 05 working days, failing which it shall be presumed that candidate is not willing to join his/her duty and chance of deployment will be given to the next candidate in the merit list. The candidates are further directed to bring the following documents (in original and one self-attested photocopy):

2. 10th class mark sheet and certificate showing Date of Birth.
3. 12th Class Mark sheet and certificate.
4. Graduation mark sheet of every year and degree/provisional Certificate.
5. B.Ed/Diploma (whichever the case may be) Mark sheet of every year and degree/provisional Certificate.
6. Post graduation mark sheet of every year and degree/provisional Certificate (wherever applicable)
7. SC/ST/OBC/EWS certificate (if applicable), issued by the Competent Authority. In case of OBC, the OBC Certificate should be issued by GNCT of Delhi.
8. Disability Certificate (if applicable).
9. Valid CTET Certificate, wherever applicable
10. Creamy layer certificate (in case of OBC candidates).
11. Two photographs
12. Photo Identity proof (Preferably Aadhar Card).



13. Address proof.

Further, concerned HOSs are directed to verify the above mentioned documents carefully within 07 working days positively and in case of discrepancy/variation of the data filled in the application form by the candidates vis-a-vis the original documents produced by the candidate, he/she shall not be joined and **his/her case shall be referred to E-V branch through the concerned District office**. After ensuring the genuinity of the documents, the applicant shall be joined in the school. In case of any clarification regarding Recruitment Rules for the concerned post, the HOS shall consult and seek advice of the Assistant Director of Education (E-II and E-III Branch, as the case may be).

Further, engagement of Guest Teachers is a stop gap arrangement and does not confer any right for permanent joining. The Guest teacher shall be relieved once a permanent teacher joins the school.
