<u>Guidelines for Organization of District Level Hands hold training of</u> <u>Special Educators on Therapeutic Services</u>

- 1. Hands-on Training of therapies like Occupational Therapy, Physiotherapy, Counseling/Behaviour Modification, and Speech Therapy shall be organized for TGT/PGT-Special Education Teachers and Resource Person (CWSN) at DPO Level under Inclusive Education- Samagra Shiksha for 2021-22.
- 2. The said training program shall be organized by District Coordinator (IE) under the supervision of concerned DPO/DDE (District).
- 3. Date and Venue of the program shall be finalized by DPOs/DDE (District) by keeping in view the social distancing norms issued by Gol due to prevailing COVID-19 conditions. The schedule shall be intimated to IE-Branch (HQ) and Samagra Shiksha (HQ) well in advance.
- 4. The Resource Persons/professionals for the program shall be the Speech therapist, Occupational Therapist, Physiotherapist, and Clinical/Rehabilitation Counselor recognized by RCI or concerned National/State Council. RPs shall be identified by District Coordinators (IEB) under supervision of DPO/DDE (Districts) concerned.
- 5. A total four sessions (90 minutes per session) shall be included in the said programme. One session each shall be provided for Occupational Therapy, Physiotherapy, Counseling/Behaviour Modification, and Speech Therapy.
- 6. Each session shall cover Introduction to specific therapy, need of said therapy to CWSN, role of SET in doing Follow up of therapies at school and home etc.
- The number of batches in which training to be organized is given in Annexure-II. Each batch shall include around 35-50 participants.
- 8. Thermal scanning of participant teachers shall be done at the entry gate itself. Sanitizers shall be made available for use by the participants. Any person found to be symptomatic shall not be allowed to enter the premises of the venue. Contingency fund shall be used for procuring sanitizing materials.
- 9. While incurring expenditure all codal formalities as per GFR-2017 shall be observed.
- 10. District Coordinators (IE) shall submit a detail report to Inclusive Education Branch within one week of organization of the program along with 05 to 10 photographs.
