1. Concerned HOS shall check their eligibility including educational qualification (XII pass), caste certificate, age (maximum 40 years as on 18.10.2021 and age relaxation as per rules), and medical fitness certificate issued by registered medical practitioners at the time of engagement.
2. Concerned HOS shall engage candidates and issue engagement letter as per Annexure-I under intimation to DPO concerned and IEB (HQ), Lajpat Nagar, subject to fulfilment of eligibility criteria mentioned at Sl. No. 1 above.
3. HOS shall get the antecedent check of Aaya/Attendant/Helper carried out from concerned Police Station within six months of joining.
4. Working hours of the Aaya/Attendant/Helper will be same as working hours of Resource Centre.
5. Remuneration of the Aaya/Attendant/Helper shall be as per the rate notified by Samagra Shiksha- Delhi from time to time.
6. These Aaya/Attendant/Helper shall be engaged for all 12 months in a financial year.

4. The Attendant/Helper/Ayah will be entitled to one day leave in each complete month which cannot be carried forward.
5. The Attendant/Helper/Ayah shall perform the services diligently and honestly. The Attendant/Helper/Ayah shall devote his/her full time, attention and efforts exclusively to the work assigned to him/her by the HoS/Resource Centre Coordinator. Working hours of the attendant/aaya/helper will be same as working hours of Resource Centre.
6. The person shall not be entitled to any benefit to which the regular employees are entitled.
7. The post offered to him/her is non- pensionable and no other benefits are payable/ available to him/her for the period of service rendered in the school.
8. The contractual engagement is liable to be terminated at any time without any notice and without assigning any reason.
9. He/she shall serve a notice of one month before resigning from his/her post or deposit one month salary for immediate termination of contract.
