**CORRIGENDUM**

Sir/Madam,

This is in continuation to the order. No. F.9/DDE (IEB)/SS/Allowance Pt.File/2021/3438-3454 dated 17.12.2021 vide which Admin Approval and Expenditure Sanction for advance drawl of a sum of Rs. 1,18,000/- (Rupees One Lac & Eighteen Thousand Only) was conveyed for payment of Girls Stipend to Children with Disabilities studying in Pre-School under Inclusive Education-Samagra Shiksha approved activities for 2021-22. In Annexure – II (guidelines) of the said order the point A (2) and B (2) may be read as “Concerned HOS shall ensure that the girls stipend are paid only to the students whose names and details given in the corresponding Annexure are correct. With regard to students whose details (disability, name, school name, out of directorate etc) are incorrect, DPO shall inform the same to Inclusive Education Branch through mail along with the correct details of such students latest by 31<sup>st</sup> December 2021”.

Further, in the said order information given in Sl. No. 11 under Copy to may be read as “FCA (Samagra Shiksha), Delhi, is requested to authorize fund to schools for expenditure at school level through DPO concerned, at Elementary Level under Inclusive Education- Samagra Shiksha, 2021-22, and also to fix the drawing limits”.
