ORDER

In order to streamline the work related to re-allocation of the schools to the relieved Guest Teachers, all the HOS of the Govt./Aided/Taken over schools of Directorate of Education are hereby directed to comply with the following directions with immediate effect:

- 1. Online experience certificate be issued for the session 2020-21 to all such Guest Teachers who have been relieved during the session or who has been working in the school till 30.06.2021. Further, all the HOSs are hereby directed to update the online attendance of all the engaged as well as relieved Guest Teachers in their school for the session 2020-21 so that the attendance of the Guest Teachers can be used for calculation of the working experience. The process to be treated as most urgent and shall be completed by 12.07.2021 positively.
- 2. Online joining of all Such Guest Teachers who have been working in the school till 01.07.2021 is to be issued w.e.f. 01.07.2021 for the session 2021-22. It has been observed that many HOS have not issued the Online Joining till date. All such HOS are directed to issue online joining by 12.07.02021 positively.
- 3. It is again reiterated that in case a Guest Teacher is to be relieved due to promotion/Transfer/Direct Recruitment of a Permanent Teacher, the Guest teacher of the concerned subject having minimum working days in the school needs to be relieved irrespective of the fact that he is working as normal Guest teacher or as a NIOS Guest teacher.



4. It has also been observed that in case of some Guest Teachers, work experience for a particular year has been issued two or more times by the concerned HOS. Hence, the Concerned guest teachers are also directed to check their working experience Certificates on the link ScrollingLinks-->Guest">http://edudel.nic.in/-->ScrollingLinks-->Guest Teacher Seniority List as per Number of Woking Days(upto 2020-21 Session). Further, the Guest Teachers are directed to get the wrong working experience certificates deleted from the concerned District or the E-V branch without fail by 12.07.2021. In case of non compliance, serious Action will be taken against the Guest Teachers concerned.

All DDEs shall also ensure the compliance of above mentioned Directions.

Non compliance of the order within the stipulated time will be taken seriously.
