  - iv. The self attested copies of Identity Cards such as Aadhar Card, PAN Card etc.



3. After verification of documents, the candidates are to attend the interview at 10:30AM on 11.04.2022 at the same venue.
  4. No TA/DA shall be provided to any candidate for attending the interview.

**In case the applicant/candidate does not appear for interview, no request will be entertained thereafter under any circumstances.** Mere attending interview does not guarantee the engagement as Consultant which is further subject to availability of matching vacancies and fulfilment of eligibility as mentioned in Public Notice dated 16.03.2022.




