**CIRCULAR**

**Sub: Guidelines issued for Nukkad Natak- Awareness Campaigning on the theme of Corona Virus, its related safety measures and Importance of Education under Samagra Shiksha.**

To create awareness in the community regarding the prevention of communicable disease through maintenance of better hygienic conditions, Nukkad Natak will be organised at the Cluster level (two times in each cluster viz 136 clusters x 2 times).

The activity will be conducted **from 4<sup>th</sup> March, 2021 to 20<sup>th</sup> March, 2021**. Total 272 Nukkad Natak will be performed in 136 clusters (Two Nukkad Natak each will be performed in every cluster) throughout Delhi.

M/s BSIW Production Pvt. Ltd. will be performing Nukkad Natak on the theme of Corona Virus, its related safety measures and Importance of Education.

Timings of the Nukkad Natak will be from 10:00 A.M to 6:00 P.M. Duration of each Nukkad Natak will be 15 minutes. In each cluster 02 Nukkad Natak enactment will be performed.

DURCC of the paired District (Mentioned below in schedule) will submit the prime locations of their District according to the dates allocated for Nukkad Natak enactment to Consultant (M &CM) at E-mail ID [consultant.media23@gmail.com](mailto:consultant.media23@gmail.com) by 03.03.2021 (Wednesday).

- vi. **CRCC shall ensure adequate safety measures keeping in mind Covid-19 Pandemic guidelines during enactment of Nukkad Natak.**
