Guidelines for Organization of Camps for distribution of Aids & Appliances to CWSN (Pre-school to Class XII) for 2021-22

- The 12 camps will be organized for distribution of Aids and Appliances to recommended Children with Disabilities (Pre-school to Class XII) of Govt., Govt. Aided, Local Body and Local Body Aided Schools of Delhi for the year 2021-22
- 2. The distribution camp is for the following categories of Children with Disabilities: Locomotor Impairment, Hearing Impairment, Cerebral Palsy, and Multiple Disability as recommended during the assessment camps for the year 2021-22
- 3. The Distribution camps should be organized between 8:00 AM to 5:00 PM.
- 4. The HOS of the concerned schools where the said program is being organized are hereby directed to organize the same by keeping in view the COVID-19 protocol.
- 5. The District Coordinators (IE), TGT/PGT Special Education Teachers, and Resource Person (CWSN) shall work together in organizing Distribution Camp.
- 6. The District Coordinators (IE) shall ensure the participation of Children with Disabilities from Govt., Govt. Aided, Local Body & Local Body Aided schools. Nodal Resource Person (CWSN) shall facilitate participation of Children with Disabilities from Local Body & Local Body Aided schools.
- 7. HOS of the schools where the Children with Disabilities, for whom the Aids and Appliances are recommended, are studying are directed to ensure that the same is collected during the camp. Advance intimation to concerned parents for receiving the aids & appliances along with the child with disability must be conveyed through school.
- 8. DPOs/DDEs (District) shall ensure that preparatory arrangements for organizing camps are made in advance.
- As the camp is schedules till 26.03.2022, the concerned account functionaries and District Coordinator (IE) shall ensure that the payment to concerned vendor, CwDs etc. are made latest by 31.03.2022.
- 10.HOS of venue shall ensure that resources/infrastructure available at the venue including sitting arrangement; public utility etc. shall be as per the norms of social distancing.
- 11. District Coordinator (IE) shall submit a report of the camp organized along with 05 to 10 photographs to this office latest by 31st Match 2022.
