## Guidelines for Development of Sensory Parks for CWSN under Samagra Shiksha for 2021-22

- Sensory Parks for CWSN in 02 Schools are to be developed as pilot project under this intervention. The schools are MCPS Co-ed School (ID-1757427) under South MCD and SBV, Shaheed Hemu Kalani Lajpat Nagar (ID-1925059), South East District.
- A committee shall be formed at DPO level consisting of DDE (District)/DPO, HOS of concerned school, District Coordinator (IE) concerned, SET/Resource Person (CWSN) posted in the school.
- 3. The said committee shall visit the concerned school and identify the site in the school compound for development of sensory park.
- 4. The list of suggestive equipments/materials/facility which may be developed or procured and installed in Sensory Park i.e. identified location in the school, for the sensory development of children with special needs (CWSN)/children with disabilities are: Swings, Sandboxes, Spinners and climbing toys, Sensory Pathway (accessible walkway specially designed and graded to stimulate sensory and motor functions), Spinning Equipment, bright colored equipments, Water wall, Mud Pool etc. In addition to it, any other equipments/materials/ facility found suitable by the committee shall also be developed/procured and installed in sensory park.
- 5. The committee shall finalize the list of equipments/materials which are to be installed in Sensory Parks and procure the said items as per the financial norms under GFR-2017. Committee shall ensure that the item procured is durable and of good quality.
- 6. The committee shall do weekly follow up to ensure that the intervention is completed by 31<sup>st</sup> March 2022 to avoid fund getting lapsed as it is a recurring activity.
- 7. Concerned District Coordinator (IEB) shall submit a report in this regard to Inclusive Education Branch after completion of intervention.
