CIRCULAR

Sub: Order dated 04.04.2022 of Hon'ble Supreme Court of India in SMW(C) No. 4/2020 in reference: Children in Street Situations.

This is in pursuance of Order dated 04.04.2022 of Hon'ble Supreme Court of India in SMW(C) No. 4/2020 in reference "Children in Street Situations."

The Hon'ble Supreme Court of India in the aforesaid order has directed as under:

"As near normalcy has been restored, the District Education Officers and District Child Protection Units are directed to ensure that there would be no impediment in the education of children who have lost either or both parents. Children who have been permitted to continue in schools pursuant to our earlier orders should be continued in the schools without any hindrance. Such of those children who have not been given the benefit of continuing in schools, shall be admitted in neighborhood schools. The State Governments/Union Territories shall submit the particulars of the educational status of all the children who have lost either or both parents."

Considering the submissions made by the learned Amicus Curiae on 02.05.2022 that there are a large number of children who have dropped out of schools due to various reasons and as per the suggestions made by the NCPCR related to the identification of children who have dropped out of school and the following measures shall be taken as per suggestions made by the NCPCR to ensure the continuance of education of such children in the aforesaid order dated 09.05.2022.

In view of the above, direction all the District Project Officers/Deputy Director of Education of all the districts are hereby directed to make sure that the education of children who have lost either of both parents to be continued.

Further, it is directed to submit their action taken/ compliance report in regard to the aforesaid the order of Hon'ble Supreme Court of India in the instant matter, to this office as and when required.
