# Guidelines for disbursing Allowances to Children with Disabilities under Inclusive Education-Samagra Shiksha for 2020-21

# A. For Local Bodies and Local Bodies Aided Schools

- The allowances (Transportation Allowance, Escort Allowance, Reader Allowance, Therapeutic Services, & Girls Stipend) shall be disbursed to Children with Disabilities (as per Annexure III-VII) studying Pre-School to Class XII in Schools of MCD, MCD Aided, NDMC, NDMC Aided, and DCB for the year 2020-21 as per instructions given below.
  - A) Reader allowance @ Rs. 660/- per child for 06 months to Students with Blindness; (Annexure IV)
  - B) Escort allowance @ Rs. 1500/- per child for 06 months to Students with Intellectual Disabilities and Blindness having disability certificate; (Annexure V)
  - C) Therapeutic Services @ Rs. 2000/- per child to Students with Autism, Cerebral Palsy, Hearing Impairment, Intellectual Disabilities, Multiple Disabilities, Speech and Language Disability, Multiple Sclerosis, Muscular Dystrophy, Haemophilia, Thalessemia, and Dwarfism; and having disability certificate; (Annexure VI)
  - D) Transport allowance @ Rs. 1200/- per child for 06 months to Students with Loco-motor disability, Cerebral Palsy, Multiple Disability, Muscular Dystrophy, and Multiple Sclerosis; and having disability certificate. (Annexure VII)
  - E) Girls Stipend @ Rs. 2000/- per child for 10 months to girls with disabilities. (Annexure VIII)
- 2. The Samagra Shiksha bank account number of the Local Bodies and Local Bodies Aided Schools is available with concerned District Accountant-SS.
- Concerned HOS after receipt of fund in Samagra Shiksha Bank Account of the school shall ensure that the allowances are paid only to the students whose name is there in the corresponding Annexure.
- 4. The HOS shall submit the Utilization Certificate to concerned Accountant-SS within a week from the date of receipt of fund towards allowances.
- Nodal RP (CWSN), Samagra Shiksha, Delhi shall coordinate with the MCD, NDMC, DCB, MCD Aided and NDMC Aided schools and provide necessary support to the account functionaries for the payment and ensure that the proper disbursal of allowances to Children with Disabilities (Class: Preschool -XII).
- If any CWSN is left out from the list, then the HoS concerned shall submit the same through DPO to Inclusive Education Branch-HQ for including the same in PAB-MHRD-2021-22, latest by 15<sup>th</sup> April 2021.

# B. For Govt. & Govt. Aided Schools of Directorate of Education

- The allowances (Transportation Allowance, Escort Allowance, Reader Allowance, Therapeutic Services & Girls Stipend) shall be disbursed to Children with Disabilities (as per Annexure VIII-XII) studying Pre-School to Class XII in Govt. & Govt. Aided Schools of Directorate of Education for the year 2020-21 as per instructions given below.
  - A) Reader allowance @ Rs. 660/- per child for 06 months to Students with Blindness; (Annexure IV)
  - B) Escort allowance @ Rs. 1500/- per child for 06 months to Students with Intellectual Disabilities and Blindness having disability certificate; (Annexure V)
  - C) Therapeutic Services @ Rs. 2000/- per child to Students with Autism, Cerebral Palsy, Hearing Impairment, Intellectual Disabilities, Multiple Disabilities, Speech and Language Disability, Multiple Sclerosis, Muscular Dystrophy, Haemophilia, Thalessemia, and Dwarfism; and having disability certificate; (Annexure VI)
  - D) Transport allowance @ Rs. 1200/- per child for 06 months to Students with Loco-motor disability, Cerebral Palsy, Multiple Disability, Muscular Dystrophy, and Multiple Sclerosis; and having disability certificate. (Annexure VII)
  - E) Girls Stipend @ Rs. 2000/- per child for 10 months to girls with disabilities (Annexure VIII)
  - 2. The allowances shall be paid through ECS or by Cheque in the name of student.
  - Concerned HOS after receipt of fund in Samagra Shiksha Bank Account of the school shall ensure that the allowances are paid only to the students whose name is there in the corresponding Annexure.
  - 4. The HOS shall submit the Utilization Certificate to concerned District Coordinator (IE) within a week from the date of receipt of fund towards allowances.
  - Concerned District Coordinator (IE) shall coordinate with the Govt. and Govt. aided schools of Directorate of Education and provide necessary support to the account functionaries for the payment and ensure that the proper disbursal of allowances to-Children with Disabilities (Class: Preschool - XII).
  - If any CWSN is left out from the list, then the HoS concerned shall submit the same through DPO to Inclusive Education Branch-HQ for including the same in PAB-MHRD-2021-22, latest by 15<sup>th</sup> April 2021.
