CIRCULAR

Subject:- Composite School Grant under Samagra Shiksha for the year 2022-23

The circular is in continuation of Circular No.F.DE.29(10)SS/Composite School Grant / 03/253 /2022-23/ 3091-3101, dated, 30.12.2022, issued by this office, regarding Utilization of Composite School Grant under Samagra Shiksha for the year 2022-23.

As a support for quality improvement, Composite School Grant, is being sanctioned on an annual basis to Government Schools (under the management of DoE, MCDs, DCB, NDMC & DSW) under the Samagra Shiksha scheme. The objective is to utilize this additional support to create conducive learning environment in schools. It is desired that this grant should be judiciously spent on various quality interventions aimed at the all-round development of the students. The Heads of Schools, in consultation with the SMCs and the Students Council may utilize this grant in their endeavour to provide a conducive environment in the school for effective Teaching Learning Process.


In this regard, HoSs/Members of SMCs/District DDEs/DPOs, DURCCs, CRCCs and AOs/AAOs concerned are requested to ensure the strict compliance of the following guidelines:

1. The HoS concern, are to utilize the Composite School Grant under Samagra Shiksha, in the consultation with SMCs & Student Council.

2. The HoS shall utilize the Grant under Samagra Shiksha as per approved norms. There is **NO REQUIREMENT** of taking any Administrative Approval and Expenditure Sanction from the DPO/District DDE for incurring expenditure out of Composite School Grant.
3. Proper Account is to be maintained by each school of the Grant received under Samagra Shiksha. Account so maintained at the level of the School is auditable and may be examined any time by the Central Team of MoE/ Team constituted at State Level/ SS-HQ Team/Team of Directorate of Education, Delhi.
4. All the HoS concerned shall follow the GFR-2017 guidelines for the expenditure norms for proper & judicious utilization of the grant. As far as possible, all procurement should be effected through GEM(Govt. E-market) and payments should be made through E-payment system in respect of vendor/supplier.
5. The Heads of schools can spend a maximum of Rs 20,000/-under any sub head in the suggestive items as already communicated vide circular under reference.
6. Rs.500/- per school for 2125 Primary schools, can be incurred for the Template/Display of Lakshya Target of NIPUN Bharat, apart from display of NIPUN Bharat Logo.
7. The Grant for various Suggestive Items can be utilized along with the reasonable maximum amount (i.e. Spending Limit) that can be spent on each such item(s). Simultaneously, it is to be ensured by the Head of the School that, as far as possible, expenditure out of "Composite School Grant" under Samagra Shiksha is made only on those items which directly facilitate better learning of students and for which funds are not available from Delhi Govt."

The rest of the content of the circular under reference remains unchanged.


