मंत्रालय, भारत सरकार की दिनांक 13 जुलाई, 1959 की अधिसूचना सं. फा. 27/59 एचआईएम (आई) के साथ पठित संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, राष्ट्रीय राजधानी क्षेत्र दिल्ली के उपराज्यपाल दिल्ली राजपत्र में प्रकाशित दिनांक 7-10-2011 की अधिसूचना सं. डीई 4(6) (350)/स्था.-IV/2011/621 के अन्तिम पैरा के बाद निम्नलिखित जोड़ते हैं, अर्थात् :—

“ केन्द्रीय माध्यमिक शिक्षा बोर्ड प्रत्याशियों को सीटीईटी की अंक तालिका इस शर्त के साथ जारी कर रहा है कि 60 प्रतिशत तथा इससे अधिक अंक प्राप्त करने वाले प्रत्याशियों को सीटीईटी योग्य माना जाएगा। इसके अलावा दिनांक 29-7-2011 के अनुसार एनसीटीई ने विशेष रूप से उपबोधित किया है कि “अर्हक अंकों में 5% तक की छूट आरक्षित श्रेणियों जैसे अनुसूचित जातियों/अनुसूचित जनजातियों/अन्य पिछड़े वर्गों/शारीरिक रूप से विकलांग व्यक्तियों को अनुमत होगी।

अतः अनुसूचित जातियों/अनुसूचित जनजातियों/अन्य पिछड़े वर्गों/शारीरिक रूप से विकलांग जैसी आरक्षित श्रेणियों से संबंधित प्रत्याशियों को केन्द्रीय माध्यमिक शिक्षा बोर्ड द्वारा संचालित सीटीईटी में अर्हक अंकों में 5% तक छूट अनुमत होगी।”

of the powers conferred by the proviso to article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. F. 27/59-Him (1) dated the 13th July, 1959, the Lt. Governor of National Capital Territory of Delhi is pleased to add the following to the Notification published in Delhi Gazette vide No. DE. 4(6)(350)/E-IV/2011/621 dated 7-10-2011 after the last para as under namely:—

“The CBSE is issuing CTET marks statement to the candidates with conditions that candidates securing 60% and above marks will be considered as CTET qualified. Further, the NCTE vide notification 29-07-2011 specifically provided that “Relaxation up to 5% in the qualifying marks shall be allowed to the candidates belonging to reserved categories, such as SC/ST/OBC/PH.

Therefore, candidates belonging to reserved categories such as SC/ST/OBC/PH shall be allowed relaxation up to 5% in qualifying marks in CTET conducted by the CBSE.”
