Further, the Contract Teachers who are found to be eligible as per norms of the SSA will be considered for re-engagement. They are also directed to come with the following documents:-

1. Printout of online filled Application Form 2014-15, bearing date & signature.
2. A set of self attested copies of applicable qualifications, caste certificates (OBC, certificate issued by the Govt of Delhi, NCT Delhi) & ID proof. All the testimonials in original are also to be brought for the purpose of verification. In case of provisional certificate, it must be issued on or after 13.01.2015).
3. Experience Certificate from the HOS of the school, where posted in 2014-15, clearly stating that the teacher has worked till 8th May 2015.
4. 2 Passport size Recent Photographs.
5. Aadhar Card photo copy and original both.
6. Any change in the residential address, Phone no, e-mail id, if different from the application form, and is to be submitted on a separate sheet along with the above documents.
