ORDER

Sub: Re-allocation of the school to relieved Guest Teachers, PGT(Economics)

Whereas Guest Teachers are engaged in Directorate of Education as a Stop Gap Arrangement against the regular sanctioned posts lying vacant so as to impart teaching to students till the posts are filled by regular teachers

And Whereas, Vide order dated 26.11.2018 in WP© No. 12600/2018, Hon'ble High Court of Delhi gave directions to Directorate of Education that

".....It is further made clear that if the petitioners are replaced by the regular appointments/promotions, the principle of last in first out shall be applied."

And whereas, in another matter, Hon'ble high Court of Delhi in WPC No. 8289/2018 titled as Dilli Atithi Shikshak Sangh Vs Director, DoE, vide order dated 30.05.2019, directed that

"...For the benefit of teachers concern, the State Government is directed to publish the state seniority list of the Guest Teachers on the website within three weeks from the receipt of this order."

And Whereas, in compliance of the said orders of Honb'le Delhi High Court, the seniority list was published in respect of all the Guest Teachers,(Post wise and Subject Wise) on the basis of number of working days.

And whereas, in order to comply the Directions of Hon'ble Court to follow LIFO(Last In First Out) in terms of working days experience, the Standard Operating Procedure has been issued vide circular dated 17.06.2021.

And Whereas, as per point No. 3 of the said circular dated 17.06.2021 "The primary criteria that will be considered for deciding Senior and Junior Guest Teacher will be number of Working days of the concerned post and subject till last session."



Hence, in order to follow the LIFO, a list of the Relieved Guest teachers of PGT(Economics) has been prepared and schools have been allocated to them as per seniority in terms of working days.

Now, therefore, the Competent Authority has decided to re-allocate the schools to following relieved PGT(Economics) Guest teachers, on the basis of principle of LIFO:
