CORRIGENDUM

**Sub: Revised Final Seniority List of Lecturers (Male Seniority No 1043 to 2316) appointed/promoted between 1.4.1994 to 31.3.2001.**

As per consolidated orders on seniority issued vide Govt. of India, Deptt. of Personnel and Training Office, Memorandum No 22011/7/86-Estt(D) dated 3.7.1986, the relative seniority of all direct recruits is determined by the order of merit in which they are selected for such appointment on the recommendations of the selecting authority.

The merit list of PGTs recruited under Direct Recruitment (DR quota) through DSSSB on 20-Nov-99 was not received from DSSSB and later the DSSSB expressed its inability to provide the merit of above Lecturers as concerned file was not traceable in the DSSSB. These Lecturers were earlier assigned with seniority based on post fixation norms vide letter No DE (2) (5)(20)/E-II/2006/PGT(M)/2859-2878 dated 5.3.2010. The Deptt. received various representations from the teachers selected in the above selection and assigned seniority based on post fixation norms alleging that their panels forwarded by the DSSSB were subject wise (in the order of merit) and assigning seniority based on post fixation norms was against the seniority rule as mentioned above. The matter was examined afresh and it was observed that as per seniority rule, the relative seniority of all direct recruits is determined by the order of merit in which they are selected for such appointment. In this case overall order of merit was not provided by the DSSSB (selecting agency), however, their subject wise panels (in the order of merit) was received by the deptt.

As such seniority of Direct Recruited teachers of above selection(based on subject wise panels) was rationalised by corrigendum No. DE.F.2(5)(20)/E-II/2006/PGT/Male/3919-23 dated 07.04.2011. A few teacher file O.A. No. 2054/2011 titled Brij Pal Singh & ors. vs GNCTD & ors. and O.A. No. 2636/2011 titled Narottam Puri & ors. vs. GNCTD & ors. in Hon'ble CAT challenging the validity and rationale of the above corrigendum. The Hon'ble CAT vide order dated 13.12.2011 and 14.12.2011 respectively in both the above OAs held that "there would be no need to examine the merits of the matter at this stage. Surely, once an order adverse to an employee is passed principle of natural justice would require that he has to put to notice and heard". In this case since the affected teachers were not given an opportunity of being heard before the issue of corrigendum dated 07.04.2011, the Hon'ble CAT set aside the corrigendum dated 07.04.2011. As such corrigendum No. DE.F.2 (5)(20)/E-II/2006/PGT/Male/3919-23 dated 07.04.2011 was cancelled vide Order No. DE.F.2(5)(20)/E-II/2006/PGT/MALE/1095-1108 dated 02.02.2012.



In order to rationalize the seniority of such direct recruited Lecturers on the basis of subject wise panels received from DSSSB, a fresh draft corrigendum was circulated amongst all concerned Lecturers working under Directorate of Education vide letter No DE. F2 (5)(20)/E-II/2006/PGT/MALE/1117-21 dated 03.02.12 to submit their objection, if any, through their HOSs/DDEs within a period of 15 days from the date of issue of above draft corrigendum as per directions of Hon'ble CAT. The seniority of above PGTs was assigned in alphabetical order of the subject so that serial No 1 of all the panels of the subjects came first and thereafter serial No. 2 of all panels of the subjects till the last number had been considered.

Most of the teachers while submitting their objections contended that earlier the Deptt had decided to finalize the seniority list of these PGTS in accordance with the priority of the subject (first of all selected candidate of English followed by Physics, Chemistry, Math, Biology, Mech. Engg., Hindi, Commerce, Economics, History, Pol. Sc., Sanskrit/Punjabi/Urdu, Home Science, Sociology, Psychology, Geography and last Agriculture) under Post Fixation Norms issued by Post Fixation Cell of Directorate of Education. The seniority list was finalized and circulated vide order dated 05.03.2010. Earlier, the Deptt had prepared tentative seniority list of PGTs (Male) which was circulated vide order dated 21.7.2009 and Deptt after taking into consideration the objections received against the aforesaid seniority list finalized it vide order dated 05.03.2010. During this period the Deptt called the ACR Dossiers of eligible candidates according to their seniority in three phases on 13.07.2010, 01.11.2010 and 19.11.2010. The deptt continued to follow the tentative seniority list dated 23.03.2006 for promotion of PGTs belonging to reserved category to the post of Vice Principal. Thus the aforesaid seniority list remained in force for more than four years. These teachers also attached letters/Ruling of Hon'ble Supreme Court in support of their claim.

As mentioned above, the recruiting agency (DSSSB) failed to submit the merit of PGTs selected under DR quota on 20/11/1999 in spite of repeated DO letters/Reminders from the then Pr. Secy (Edn), Director (Edn), Addl DE (Admn). The finalization of above seniority got delayed for almost 10 years and after confirmation from DSSSB that main file on the above selection was not traceable and in order to ensure continuity of promotion of PGTs (feeder cadre) to the post of Vice Principal, the Deptt had decided to finalize the above seniority based on Post Fixation Norms. Few PGTs (ST Category) from the above selection had already been promoted as Vice Principal in the year 2008-09 and 2009-10. However, changes in the seniority of these ST teachers will have no effect as above seniority is not changed but rationalized. As regards contention of the teachers that seniority once finalized cannot be changed, the Deptt had already clarified in the draft corrigendum that panels received from the DSSSB against the above selection were subject wise and the fact that no subject is put to advantage/disadvantage vis-a-vis other subject, the earlier seniority had been revised in order to readdress the legitimate concern of teachers recruited under the above selection. In addition, as per Civil Appeal No. 879 of 2000 decided on March 10, 2003 titled Bimlesh Tanwar vs State of Haryana and Ors, also quoted by the teachers, Hon'ble Supreme Court held that "Seniority is not a



fundamental right. It is merely a civil right. Inter se seniority of the candidates who are appointed on the same day would be dependent on the rules governing the same. In the absence of rules governing seniority an executive order may be issued to fill up the gap. Only in the absence of a rule or executive instructions, the court may have to evolve a fair and just principle which could be applied in the facts and circumstances of the case". As such in the instant case the merit list had not been provided by the sponsoring agency ie DSSSB as per seniority rules, the Deptt had every right to fill up the gap by issuing an executive order as had been done then. Few teachers suggested that in the absence of merit list from DSSSB, percentage of marks obtained in Post Graduation by the teachers or date of joining may be considered for finalization of seniority. As clarified earlier, this suggestion was not in conformity with the seniority rules. The representationists had also not suggested any other more rationalized way of assigning seniority in the absence of said merit list. Therefore, their contentions for changing the seniority list had not been found tenable.

In view of the above, necessary minor corrections required to be made on the basis of objections received from Lecturers of above selection had been incorporated in the above list. Accordingly, the above seniority list was finalized through the corrigendum bearing No. DE.F2(5)(20)/E-II/2006/PGT/MALE/5995-6000 dated 25.07.2012 and circulated as final seniority list of Lecturers (Male Seniority No 1043 to 2316) appointed/promoted between 1.4.1994 to 31.3.2001 for information to all.

However, Sh. Brij Pal Singh along with 10 other PGTs challenged the seniority list of lecturers (Male) issued vide corrigendum bearing No. DE.F2(5)(20)/E-II/2006/PGT/MALE/5995-6000 dated 25.07.2012 by way of filing OA No. 3201/2012 titled Brij Pal Singh & ors. vs GNCT Delhi & ors. before Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi. Hon'ble CAT disposed of OA No. 3201/2012 vide order dated 19.05.2015 with the following directions:

*"10. In the circumstances, we are of the considered view that the seniority of the PGTs of 1999 batch (direct recruits) can be fixed with regard to the priority subjects as well as the position of the candidates in the subject wise panel, i.e., the topper of the top priority subject (subject with maximum vacancies) should be placed at Sl. No. 1 and so on. Such solution is acceptable by the respondents and they have already mentioned the proposed seniority list in para 5 of their additional affidavit.*

*11. In the circumstances, the OA is disposed of with a direction to the respondents to fix the seniority of direct recruit PGTs of 1999 batch in terms of the stand taken by the respondents in para 5 of the additional affidavit as expeditiously as possible. No costs."*

Hence, in compliance of order dated 19.05.2015 passed by Hon'ble CAT in OA No. 3201/2012 titled Shri Brij Pal Singh & ors. vs GNCT of Delhi & ors., the final seniority list in respect of lecturers (Male Seniority No. 1043 to 2316) appointed/promoted between



01.04.1994 to 31.03.2001 issued vide corrigendum bearing No. DE.F2(5)(20)/E-II/2006/PGT/MALE/5995-6000 dated 25.07.2012 is revised for information to all concerned is as under:
