ORDER

Whereas, Smt. Krishna Kumarti was a candidate amongst 1492 candidates selected for appointment for the post of TGT (Sc.B) in the year 1983-84.

And whereas, the Directorate of Education has appointed 527 candidates in the first instance and thereafter 127 candidates but Smt. Krishna Kumari was not in those candidates.

And whereas, department conducted interviews in the year 1986 and Smt. Krishna Kumari being selected was appointed as TGT (Sc. B) wef 17/07/1986.

And whereas, in compliance of the Judgment of the Hon'ble Supreme Court of India in CA No. 1900/1987 in the matter of Union of India V/s Ishwar Singh Khatri and Others Smt. Krishna Kumari has been assigned Seniority No. 1052 taking her date of appointment as 20/01/1984.

And Whereas, the Hon'ble Supreme Court of India has directed that the Directorate of Education will assign the proper seniority as per ranking in the selection in the year 1983-84 over the persons appointed in the interregnum. There was no mention of pay fixation / notional Pay Fixation in the order passed by the Hon'ble Supreme Court of India.

And Whereas, in compliance of the Hon'ble CAT Judgment dated 29/11/06 in O.A No. 2469/2006 the representation of Smt. Krishna Kumari has been examined and considered.

Now , therefore, in view of order No. Director of Education 3 (144) / E. III / 95/ 6534-89 dated 7/05/2004 of Addl. Director of Education (Admn), the representation of Smt. Krishna Kumari TGT (Sc) stands disposed of allowing her seniority wef 20/01/1984 and not acceding to her request for notional Fixation of Pay.
