- 2. The expenses towards petrol/Diesal/CNG will be borne by supplier.
- 3. The expenses towards hiring/salary etc. of driver will also be borne by the supplier.
- Any accidental charges/damage to the vehicle or compensation to accident victims and all claims
  arising because of accident will be borne by the contractor.
- The maintenance of Car viz servicing/oiling/adjustment/replacement of parts will be borne by the supplier.

- 10. The Start/Stop of mileage will be the first and last duty point. No dead mileage will be allowed.

- 11. Hired vehicles should not be older than two years.
- Driver of the hired vehicle should hold a valid commercial license and should follow the traffic rules and other regulations.
- 13. As far as possible that the vehicles and the driver attached to a particular officer will not be changed.
- 14. The vehicle should be registered with transport department as commercial vehicle as per the guidelines issued by the General Administrative Department GNCT of Delhi No. F/IC/827/07/GAD /Vol-II/1876 dated 18/6/2010.
- 15. No escalation of cost during the tenure of the tender will be allowed and the rates quoted in tender/approved will be valid for a period of one year.

- 19. The log book for each vehicle shall be maintained and must be signed by the controlling officer. The log book be submitted in Care Taking Branch of Distt. East after completion of the month by 10<sup>th</sup> of every next month.
- 20. In case the vehicle is out of order, a substitute vehicle shall be provided by the contractor immediately. In case vehicle doesn't report on time/ does not report; the report Department would have a right to higher a vehicle from the market & additional cost incurred by the department will be borne by the contractor.
- 21. The penalty will be levied without further hearing and issuing SCN if terms and conditions are violated. In ease of recurrence of violation of terms and conditions the firm shall be blacklisted and debarred to participate in the tender in this department for a period of five years.
- 22. The user will verify the billing amount.
