**1. General**

The bid on GeM is being issued to seek response from the eligible bidder(s) to **supply (with installation)** a number of **6158 Writing (Green) Boards** in various Government Schools under Directorate of Education, GNCT of Delhi. Entire process (Supply & Installation) is to be done **within 90 days** of issuance of Purchase Order. **The Estimated Cost of Project is Seven (7) Crore approx.**

### **3. Eligibility of Bidder**

The bidder must fulfill the following eligibility conditions-

- The Bidding Firm should be a bonafide manufacturer having valid Manufacturing/Factory License issued by Central /State Govt. Department/Agency. Bidding in the form of Joint Venture/Consortium, Dealers/Distributor is not permitted.
- In case the bidding firm is blacklisted or debarred for any fault from any Govt. Department/Organization will not be eligible for bidding.
- The firm should be registered under Goods & Service Tax (GST) in GNCT of Delhi. (GST Registration Certificate in GNCT of Delhi should be uploaded/submitted)
- The bidding firm should not have incurred any loss in two (02) years during the last three financial years ending 31st March 2017. The average annual turnover ending with 31st March 2017 should be equal and above to Rs.2.10 Crore (i.e. 30% of the estimate cost of the project) in last 03 financial years. (Audited Balance Sheet & summary of turnover for last 03 financial year certified by Chartered Accountant should be submitted)

### **4. Earnest Money Deposit**

- The bidder(s) will have to submit 2% of the project value (**Rs.14 Lakh**) as Earnest Money Deposit in the form of Account Payee Fixed Deposit Receipts / Bank guarantee from any of Scheduled Bank in favour of "Director of Education, Government of National Capital Territory of Delhi, Old Secretariat, Delhi". Earnest Money will not be accepted in the form of Cash/ Money Order. The bid security shall remain valid for a period of 45 days beyond the Final Validity period \*\*.

Note- \*\* 165 days (120 days + 45 days)

- The exemption from the Earnest Money will be admissible to bidder(s) registered for tendered item with National Small Industries Corporation (NSIC) and having valid exemption (monitory limit equal & above of required EMD as mentioned above).
- EMD/NSIC Exemption (in superscripted sealed envelope) must be submitted physically (in Hard Copy) in the office of bid issuing authority [Room No. 256, Care-Taking Branch, Directorate of Education, GNCT of Delhi, Old Secretariat Building, Delhi-110054 Tel- (011)-23890253/52] on or before 10.04.2018 till 01.00 pm.
- If, Hardcopy of EMD/NSIC Exemption not received physically within the stipulated time, such bid(s) cannot be opened for technical evaluation and will be rejected summarily. No correspondence will be entertained regarding delay in submission or other issues in this regard.
- Bid security/ EMD of the bidder will be forfeited, if the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect within the period of the validity of its tender.
- EMD of unsuccessful bidder(s) will be returned to them approximately within 30 days after award of contract. No interest is payable on EMD amount.

## **5. Rate to be quoted by the bidder**

The Bidder must quote only single rate (per unit) for inclusive of all taxes/charges- GST, freight, octroi, transportation, installation etc. The tender which is found with double/multiple/optional rates will be summarily rejected.

## **6. Award of work contract**

Successful technically qualified bidder whose price bid is found to be the lowest rate (L-1) will be awarded work contract.

## **7. Performance Guarantee**

- The successful bidder will be required to submit Performance Guarantee @ 5% (Five Percent) of the cost of awarded work within 15 days of the award of the work.
- This guarantee shall be in the form of Account Payee Fixed Deposit Receipt/Bank Guarantee from any of scheduled bank in accordance with the prescribed form. In case the bidder fails to deposit the said performance guarantee within the period, the Earnest Money deposited by the bidder shall be forfeited automatically without any notice to the bidder and the work awarded would be cancelled.
- The performance guarantee must remain valid for the period of 60 days beyond the date of completion of all the contractual obligations of the supplier. No interest is payable on Performance Security/Guarantee by the Department.
- If at any stage, the bidder deviates from the terms and conditions of the Contract Agreement or his performance are found to be unsatisfactory, Agreement of contract shall be liable to be terminated without any notice and the Performance Security shall be forfeited.

## **8. Schedule of Supply**

- The successful bidder will supply & install the writing (green) boards in approx 400 school buildings located in Delhi. (List attached at Annexure-'A') The supply & installation to be done either by the bidder or through their authorized distributor or dealer in Delhi against a sale invoice with GST Registration in Delhi. The responsibility of all the contractual obligations shall be on the bidder firm.
- The entire process (supply & installation) is to be completed within 90 days from the date of award of the contract. No extra charges i.e. cartage/freight/labour charges etc. shall be paid for delivery/installation of boards in the schools. Supplier shall inform the date of delivery to school in one day advance so that necessary arrangements are made by concerned Head of School.



### **9. Verification of Documents/Claims Made By The Bidders**

This Directorate or its representative shall have the liberty to visit the main manufacturing unit for verification of the documents/claims made by the bidder for which arrangements for the inspection of the manufacturing unit, if desired by Directorate of Education, Government of National Capital Territory of Delhi shall be made by the bidder.

### **10. Quality Control**

The department reserves the right for collecting random samples and testing the quality & standard of the product in an approved testing laboratory for assessment of quality. Testing charges will be borne by the contractor. The supplies, if found not up to the mark as per approved norms or deficient due to any other reason shall be rejected at once without assigning any reason and will have to be removed /replaced immediately. In case of failure to do so, the rejected supply can be disposed off by the Department and no claim for the same shall be entertained. In addition to above, the performance security shall also be forfeited.

### **11. Penalty for Non-Commencement, Slow Performance or Delay In Supply.**

In case of delay in providing Services, liquidated damages not exceeding an amount equal to 0.2% (Zero point one percent) of the Agreement Value per day, subject to a maximum of 10% (Ten per cent) of the Agreement Value will be imposed and shall be recovered by appropriation from the Performance Security or otherwise. However, in case of delay due to reasons beyond the control of the Services Provider, suitable extension of time shall be granted.)

### **12. Overpayment/Underpayment**

If as a result of post payment audit or otherwise, any overpayment is detected in respect of any services rendered or alleged to have been done by the contractor under the contract, the contractor shall pay back the overpayment or it shall be recovered by the department from the contractor. If any underpayment is discovered, the amount shall be duly paid to the contractor by the department.

The contractor shall provide the copies of relevant records during the period of the contract or otherwise even after the contract is over when ever required by the department etc.

## **INDEMNITY**

The bidder shall indemnify the Department against all damages/charges and expenses for which the Government may be held liable or pay an account of the negligence of the bidder or their staffs or any person under their control whether in respect of accident, injury to the persons or damages to the property of any member of the public or any other person or in executing the work or other wise and against all damages and demands thereof.

## **FORCE MAJEURE**

If at any time during the currency of contract, either party is subject to force majeure which can be termed as civil disturbance, riots, strikes, tempest, act of God etc. which may prevent either party to discharge his obligation, the affected party shall promptly notify the other party about happening of such an event. Neither party shall be, reason of such event, be entitled to terminate the contract in respect of such performance of their obligations. The obligations under the contract shall be resumed as soon as practicable after the event has come to an end or cease to exist. The performance of any obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist.

## **Dispute Resolution.**

(A) Any dispute and or difference arising out of or relating to this contract will be resolved through joint discussion of the authorities/representatives of the concerned parties. However, if the disputes are not resolved by joint discussions, then the matter will be referred for adjudication to a sole Arbitrator appointed by the Hon'ble Lt. Governor, Delhi.

(B) The award of the sole Arbitrator shall be final and binding on all the parties. The arbitration proceedings shall be governed by Indian Arbitration and Conciliation Act 1996 as amended from time to time.

(C) The cost of Arbitration shall be borne by the respective parties in equal proportions. During the pendency of the arbitration proceeding and currency of contract, neither party shall be entitled to suspend the work/service to which the disputes relates on account of the arbitration and payment to the contractor shall continue to be made in terms of the contract. Arbitration proceedings will be held at Delhi/New Delhi only.

## **Jurisdiction of court.**

The courts at Delhi/New Delhi shall have the exclusive jurisdiction to try all disputes, if any, arising out in the project.
