- 8. The articles ordered/supplied would be subject to inspection by the authorized team/ representatives of the Director of Edu. at any place to be decided by the department. The goods supplied/ordered are liable to be rejected, if the same do not come up to prescribed specification/approved samples. The tenderer has to bear all the cost at his own risk
