OFFICE ORDER

Whereas Sh. Jitender Kumar(19810927) was regularized as Lecturer(Pol.Sc.) w.e.f. 16/2/1989 vide order No.DE.2(2)(17)/E-II/DPC/2008/PF/22457-477 dated 11/6/2009 on the grounds that Sh. Lakhmi Chand, junior to him as TGT had been granted regularization as Lecturer with effect from said date;

And whereas it has subsequently come to notice that the said Sh. Jitender Kumar presently working as Vice Principal in GBSSS No.2, Blk-C, Yamuna Vihar(1104008) had acquired the qualifications of M.A.(Pol.Sc.) on 17/10/1988 which indicates that he was eligible for promotion in the year 1989-90 and was not eligible in the year 1988-89 for which the cut off date for determination of eligibility was 31/3/1988 while Sh. Lakhmi Chand though junior to him had acquired qualifications in 1981 well before the cut off date. Hence Sh. Jitender Kumar is not entitled to regularization as Lecturer(Pol.Sc.) w.e.f. 16/2/1989;

And whereas the case was subsequently placed before the review DPC held on 21/4/2010 which has recommended that the said Sh. Jitender Kumar be granted regularization as Lecturer(Pol.Sc.) Male S/C w.e.f. 20/3/1990 as already done vide office order No.17752-852 dated 17/6/1996.

On the basis of the recommendations of the DPC held on 21/4/2010, it is therefore ordered that the regularization granted to the said Sh. Jitender Kumar(19810927) as Lecturer(Pol.Sc.) Male S/C w.e.f. 16/02/1989 vide order DE.2(2)(17)/E-II/DPC/2008/PF/22457-477 dated 11/6/2009 is hereby cancelled with immediate effect and the Seniority No.1371(-A) allotted to him in the Seniority list of Lecturer Male (Blk year 1976-90) is also cancelled with immediate effect. Sh. Jitender Kumar(19810927) will stand regularized as Lecturer(Pol.Sc.) Male S/C w.e.f.20/3/1990 and will be placed at Seniority No.1598 in the Seniority List of Lecturer (Blk year 1976-90).
