**CIRCULAR**

**Subject: Redeployment of Guest Teachers for the Academic session 2017-18.**

1. Guest Teachers who have worked in Academic session 2016-17 and 2017-18 and relieved on account of joining of regular teacher/surplus due to PFC may be redeployed for Academic Session 2017-18 on priority basis against vacant post, only as per requirement in schools.
2. DDE/HOS shall not redeploy any Guest Teachers who have been removed due to misconduct, misbehavior, and leave without permission of HOS, poor performance, resigned due to personal reason.
3. Now, all the eligible Guest Teachers who have worked earlier in the Academic Session 2016-17 and 2017-18 in the schools of Directorate of Education may contact Deputy Director of concerned district.
4. All the applications submitted in E-V branch or received from Directorate Headquarter are hereby forwarded to concerned Deputy Director office for taking action as per guidelines. Any other Guest Teacher, for whom documentary evidence is available of having worked as Guest Teacher in our schools, during 2016-17/2017-18, and who has not been removed due to reasons cited in para 2, may also be redeployed in case of vacancies, only as per requirement in schools, by the Dy. Director of concerned District.
