Subject:- Ensuring of admission of all eligible selected candidates under EWS/DG & CWSN in Private Unaided Recognized Schools of Delhi during session 2022-23 in accordance to the directions of double bench of Hon'ble High Court in the matter titled JUSTICE FOR ALL Vs VENKATESHWAR GLOBAL SCHOOL & others in LPA 5/2022 & CM APPLs. 474-477/2022, 481/2022.

Refer to this office earlier communication dated 02.06.2022 vide which instruction were issued in compliance to the order dated 26/05/2022 passed by Hon'ble High Court, for ensuring admissions of all eligible selected candidates under EWS/DG & CWSN category in Pvt. Unaided Recognized School during session 2022-23 (copies enclosed for reference) irrespective whether the admissions under the open seats have been done by the schools so far as per their declared strength or not.

In this connection, the attention of all Districts DDEs is invited that despite clear direction of Director (Education), admissions of all remaining eligible selected candidates have not been got done so far which has been viewed seriously by the Director (Education).

All District DDEs must also recall to the proceeding held before the Hon'ble Committee on Welfare of SC/ST at Delhi Vidhan Sabha wherein there were clear directions to ensure the admission of all eligible candidates under EWS/DG & CWSN category. Further as per circular dated 14/06/2022 the admission process in pending cases was to be completed by 24.06.2022 but the status of pending admissions of candidates as per portal is as under:-

In view of above, all the District DDEs are hereby again requested to ensure the following actions:-

- 1. To get the status of remaining 1747 candidates updated by today evening positively.
- 2. To ensure the admission of all eligible selected In-waiting candidates by today evening positively.

- 3. To depute D.E nominee's to cross verify the status of Not-reported and Rejected candidates as filled by the respective Pvt. Schools and to ensure whether the candidates have not reported genuinely and the rejections done by the school are on reasonable and prescribed grounds or not. A detailed report must be submitted within 7 days of issuance of this letter without fail.
- 4. Actions must be taken against the defaulter private schools in accordance to this office circular dated 02.06.2022.

Non-compliance of this circular will invite disciplinary action against the concerned defaulting officer.
