CIRCULAR

Sub: Preparation of Home Based Intervention Plan (HBIP) for CWSN/CWD by Resource Person (CWSN)

In pursuance of orders issued by the Health and Family Welfare Department, GNCTD regarding the suspension of classes in schools due to the spread of Novel Corona Virus (COVID-19) pandemic, the face to face academic activities could not commence in schools till date.

Section 16 (iv) of the Rights of Persons with Disabilities (RPWD) Act 2016, provides that the appropriate govt. shall provide necessary support individualized or otherwise in environments (to the PWDs) that maximize academic and social development consistent with the goal of full inclusion.

Therefore, in order to provide the necessary remediation and support services to the children with disabilities (CWSN/CWD), all the Resource Person (CWSN) working under Samagra Shiksha are directed to develop and disseminate a Home Based Intervention Plan for each CWSN/CWD studying in their respective school. The guidelines for the same are given below:

- 1. The Home Based Intervention Plan shall be developed in a practical manner so that it is feasible for the parents, caregivers and other family members to implement it within the home setting using minimal resources.
- 2. Child's safety must be accorded as the highest priority while planning the activities.
- 3. The Home Based Intervention Plan shall be in synchronization or in continuation to the IEPs prepared by the Resource Person (CWSN) for each CWSN/CWD during the last term, as much as possible.
- Depending upon the current functioning of the child, the Home Based Intervention Plan maybe divided subject wise (according to the current class level) or skill wise for each CWSN/CWD.
- 5. For subject-wise preparation of the plan w.r.t. the students following the regular curriculum, the Special Educators/ Resource Person (CWSN) may refer to the online versions of the textbooks available on the following links may also be referred for the online content:

- 6. For skill-wise preparation of the plan w.r.t. the students with intellectual disability (ID), autism spectrum disorder, multiple disability or severe hearing loss, the activities may be broadly divided into the following categories:
 - <u>Activities of Daily Living:</u> consisting of the activities relating to the personal care and grooming skills such as independent brushing, bathing, dressing etc.
 - <u>Functional Academics:</u> consisting of the activities relating to the basic reading, writing, and arithmetic.
 - <u>Domestic Skills:</u> consisting of the activities facilitating the day to day chores to be performed within the home setting such as peeling, chopping, assisting in washing/drying clothes etc.
 - Recreational Skills: consisting of the indoor activities such as carom, ludo etc. to be played with the immediate family members. It may also include doing simple exercises and yoga for maintaining fitness.
 - Art & Craft: consisting of simple and doable art and craft activities involving cutting and pasting, drawing etc.
 - <u>Pre-Vocational Skills:</u> consisting of the activities such as simple sewing or stitching button, making tea etc.
 - Sensory activities may also be suggested to the parents of children having sensory problems.
- 7. Resource Person (CWSN) will ensure that the activities planned under the above suggestive areas are clearly stated according to the present functioning of the child.
- 8. The parents or the caregivers must be informed to monitor and strictly supervise the CWSN/CWD while he/she is doing the activity. It will ensure the child's safety and will enable the parents to provide feedback in each of the planned area to the concerned Resource Person (CWSN).
- 9. Home Based Intervention Plan should not include any activity that requires the CWSN/CWD to make any social visit either to the neighborhood or the local market.
- 10. Mode of Communication: The Home Based Intervention Plan will be communicated to the parents or the caregiver of CWSN/CWD through the telephone. They may also be provided with the necessary instructions using a video call/online, provided they have the facility of the same in their respective phone.
- 11. The parents or the caregivers are to be provided with the demonstration of the worksheets by the concerned Resource Person (CWSN) that may be used for the CWSN/CWD to reinforce the particular concept.

- 12. In case of CWSN/CWD who do not have access to mobile phones with video calling facility, concerned Resource Person (CWSN)shall prepare hardcopy of worksheets and distribute to parents of CWSN from school. No CWSN/CWD shall be called for receiving worksheets. Further, while distributing such worksheets the guidelines issued by MHA, Gol shall be followed strictly.
- 13. Duration of Plan: Home Based Intervention Plan will be prepared fortnightly and accordingly communicated to the parents or caregivers. Concerned Resource Person (CWSN) will take the feedback of the planned activities once in three days (till the end of the fortnight plan).
- 14. The plan shall be revised every fortnightly and accordingly communicated to the parents.

Instructions regarding preparation of report

- 15. All the Resource Person (CWSN) shall submit the report to the concerned District Coordinator (IEB) towards the end of the fortnight (as per the Performa given at Annexure-I).
- 16. Plus curriculum and regular curriculum activities are to be mentioned separately in Annexure I as per the activities planned for the students.
- 17. In the format, feedback of the parents/caregivers is to be filled in terms of difficulties faced by them in implementing the plan and suggestions/feedback of the parents on the plan.
- 18. Suggestions given by Resource Person (CWSN) to parents w. r. t difficulties faced by them in implementing the plan to be mentioned at column 11.
- 19. A sample of report has been attached at Annexure-II for the reference purpose.
- 20. All Resource Person (CWSN) shall also submit a record of the CWSN/CWD (Name, Class and the Contact no.) of their concerned school who are untraceable.
- 21. The reports shall be maintained for record purpose; since they will be considered a part of program planning for the session 2020-21.

Instructions for District Coordinator (IEB)

- District Coordinator (IEB) to ensure that each Resource Person (CWSN) of concerned district are developing and implementing the Home Based Intervention (HBI) Plan to ensure the continuity of learning of CWSN/CWDs during the lockdown period.
- District Coordinator (IEB) shall include such reports submitted by Resource Person (CWSN) in the compiled report being submitted to Inclusive Education Branch, Lajpat Nagar – IV for Govt. Schools.
