- All original certificates along with their original mark sheet and certificate /provisional certificate/degree of 10th, 12th, ETE/JBT/B.El.Ed or equivalent (for primary teacher).
- SC/ST/OBC Caste certificates (if claiming benefits of reservation).
- Certificate of disability issued by the appropriate authority (if applied in PH category)
- Two photographs.
- Photo Identity Card
- Affidavit (Notarized). Format attached.
- **The candidates shall also furnish self attested photocopy set of the above documents in the Principal office of school allotted.**

Note- Mere allotment of school does not guarantee the engagement of the candidate; it is further subject to the fulfillment of eligibility criteria as per existing RR.s of DOE.


