GUIDELINES FOR DISBURSING ALLOWANCES TO CHILDREN WITH DISABILITIES (CLASS IX TO XII) UNDER INCLUSIVE EDUCATION-SAMAGRA SHIKSHA FOR 2021-22

C. For Local Bodies and Local Bodies Aided Schools

- The allowances (Transportation Allowance, Escort Allowance, Reader Allowance, Therapeutic Services, & Girls Stipend) shall be disbursed to Children with Disabilities (as per Annexure III-VII) studying in Class IX to Class XII in Schools of MCD, MCD Aided, NDMC, NDMC Aided, and DCB for the year 2021-22 as per instructions given below.
 - A) Reader allowance @ Rs. 2500/- per child to Students with Blindness; (Annexure III)
 - B) Escort allowance @ Rs. 2500/- per child to Students with Intellectual Disabilities, Muscular Dystrophy, Cerebral Palsy, Autism Spectrum Disorders, and Blindness; (Annexure IV)
 - C) Therapeutic Services @ Rs. 2000/- per child to Students with Autism Spectrum Disorder, Cerebral Palsy, Hearing Impairment, Intellectual Disabilities, Multiple Disabilities, Speech and Language Disability, Multiple Sclerosis, Muscular Dystrophy, Hemophilia, Thalessemia, and Dwarfism; (Annexure V)
 - D) Transport allowance @ Rs. 1000/- per child to Students with Loco-motor disability, Cerebral Palsy, Dwarfism, Thalessemia, Sickle Cell Disease, Autism Spectrum Disorder, Intellectual Disabilities, Multiple Disability, Muscular Dystrophy, Low Vision, and Multiple Sclerosis. (Annexure - VI)
 - E) Girls Stipend @ Rs. 2000/- per child to girls with disabilities. (Annexure VII)
- 2. Concerned HOS shall ensure that the allowances are paid only to the students whose name is there in the corresponding Annexure.
- 3. The HOS shall submit Expenditure report to concerned Accountant-SS within a week from the date of receipt/authorization of fund towards allowances.
- 4. Nodal RP (CWSN), Samagra Shiksha, Delhi shall coordinate with the MCD, NDMC, DCB, MCD Aided and NDMC Aided schools and provide necessary support to the account functionaries for the payment and ensure that the proper disbursal of allowances to Children with Disabilities (Class: IX XII).
- If any CWSN is left out from the list, then the HoS concerned shall submit the same through DPO to Inclusive Education Branch-HQ for including the same in PAB-MHRD, latest by 15th January 2022.

D. For Govt. & Govt. Aided Schools of Directorate of Education

- The allowances (Transportation Allowance, Escort Allowance, Reader Allowance, Therapeutic Services & Girls Stipend) shall be disbursed to Children with Disabilities (as per Annexure III-VII) studying in Class IX to Class XII in Govt. & Govt. Aided Schools of Directorate of Education for the year 2021-22 as per instructions given below.
 - A) Reader allowance @ Rs. 2500/- per child to Students with Blindness; (Annexure III)
 - B) Escort allowance @ Rs. 2500/- per child to Students with Intellectual Disabilities, Muscular Dystrophy, Cerebral Palsy, Autism Spectrum Disorders, and Blindness; (Annexure IV)
 - C) Therapeutic Services @ Rs. 2000/- per child to Students with Autism Spectrum Disorder, Cerebral Palsy, Hearing Impairment, Intellectual Disabilities, Multiple Disabilities, Speech and Language Disability, Multiple Sclerosis, Muscular Dystrophy, Hemophilia, Thalessemia, and Dwarfism; (Annexure V)
 - D) Transport allowance @ Rs. 1000/- per child to Students with Loco-motor disability, Cerebral Palsy, Dwarfism, Thalessemia, Sickle Cell Disease, Autism Spectrum Disorder, Intellectual Disabilities, Multiple Disability, Muscular Dystrophy, Low Vision, and Multiple Sclerosis. (Annexure - VI)
 - E) Girls Stipend @ Rs. 2000/- per child to girls with disabilities. (Annexure VII)
- 2. Concerned HOS shall ensure that the allowances are paid only to the students whose name is there in the corresponding Annexure.
- 3. The HOS shall submit Expenditure report to concerned Accountant-SS within a week from the date of receipt/authorization of fund towards allowances.
- 4. Concerned District Coordinator (IE) shall coordinate with the Govt. and Govt. aided schools of Directorate of Education and provide necessary support to the account functionaries for the payment and ensure that the proper disbursal of allowances to-Children with Disabilities (Class: IX XII).
- 5. If any CWSN is left out from the list, then the HoS concerned shall submit the same through DPO to Inclusive Education Branch-HQ for including the same in PAB-MHRD, latest by 15th January 2022.
