# GUIDELINES FOR DISBURSING ALLOWANCES TO CHILDREN WITH DISABILITIES (CLASS I TO VIII) UNDER INCLUSIVE EDUCATION-SAMAGRA SHIKSHA FOR 2021-22

# A. For Local Bodies and Local Bodies Aided Schools

- 1. The allowances (Transportation Allowance, Escort Allowance, Reader Allowance, Therapeutic Services, & Girls Stipend) shall be disbursed to Children with Disabilities (as per Ahmexure III-VIII) studying from class Pre-Primary to class VIII in Schools of MCD, MCD Aided, NDMC, NDMC Aided, and DCB for the year 2021-22 as per instructions given below.
