The Home Based Education (HBE) is being implemented by Resource Person (CWSN) engaged under Inclusive Education, Samagra Shiksha, Delhi, in addition to their exiting duties and responsibilities, with a view to mainstream them in the general education system.

- 2. To ascertain the level of daily living skills & need based educational assessment of identified OoSCWSN and prepare Individualized Educational Plan (IEP) and Individual Family Service Plan (IFSP) of the child and family.
- 3. To carry out survey & door-to-door verification in the nearby localities where OoSCWSN were identified during academic year 2021-22 in 136 clusters of Delhi.
