**ORDER**

**Subject: Re-deployment of Guest Teachers working in the Govt. Schools/Aided Schools/Taken Over Schools of Delhi for the academic Session 2022-2023.**

Whereas the services of Guest Teacher working in the Govt. Schools/Aided Schools/Taken Over Schools of Directorate of Education, Govt. of NCT of Delhi were discontinued vide order No. DE 18.2(73)/E-V/2020/Part/427-432 dated 11.05.2022 keeping in view of circular No. DE 2393/Sch.Br./2022-23/129 dated 25.02.2022 issued by School Branch, Dte. Of Education, GNCT of Delhi, due to the declared summer vacations w.e.f. 11.05.2022 to 30.06.2022.

Now all the guest teachers who have been working in the Govt. Schools/Aided Schools/Taken over schools of GNCT of Delhi till 10.05.2022 are hereby directed to report to the HOS concerned on the date of re-opening of schools i.e. w.e.f. 01.07.2022 without fail. In case a guest teacher fails to report to the school within 03 working days it will be presumed that he/she is no longer interested for engagement and alternative arrangement will be made.

However, this will not apply in case of guest teachers who have been disengaged due to misconduct, misbehaviour, remained absent without permission of the HOS, poor performance or resigned due to personal reasons.

Further all the HoSs of Govt. Schools/Aided Schools/Taken Over Schools of Directorate of Education, Govt. of NCT of Delhi are directed to issue online experience certificate for the session of 2021-2022 in r/o of all such guest teachers who have been relieved during the session or who have been working in the school till 30.06.2022. All the HOSs are also directed to update the online attendance of all the engaged as well as relived guest teachers in their schools for the session of 2021-2022 so that the attendance of the guest teachers can be used for calculation of the working experience/days.

This issues with the prior approval of the competent authority.
