ORDER

REJECTION/CANCELLATION OF CANDIDATURE IN R/O Mr. RINKU KUMAR FOR THE POST OF TGT PUNJABI (MALE) UNDER POST CODE 56/21.

Whereas, Mr. RINKU KUMAR D.O.B 30.11.1987, Roll No.112505600060 has been provisionally nominated & selected by the DSSSB for appointment to the post Post of TGT Punjabi (Male) Post Code 56/21 under SC category in Directorate of Education, Govt. of NCT of Delhi.

And Whereas, during the preliminary scrutiny of dossier of candidate it has been found that candidate studied PUNJABI as additional subject from Kurukshetra University, Haryana during in 2015-16 (Part II & III, Two yrs.). The candidate has studied B.A. during 2008-2010(Three years) from Kurukshetra University, Haryana (without Punjabi).

And whereas, as per RRs to the Post of TGT (Punjabi) (Male) B.A. (Honours) in one of the Modern Indian Language (MIL) concerned or B.A. with MIL concerned as one of the elective subjects from a recognized university having 45% marks in aggregate with one additional language or one school subject at degree level.

And whereas, as per RRs and the matter of candidate was considered in this Directorate and the candidature of candidate has been cancelled by the Competent Authority as the candidate has not having essential qualification as per RRs for the post of TGT Punjabi Male.

Therefore, in view of the above facts and circumstances, the candidature of Mr. RINKU KUMAR D.O.B. 30.11.1987, Roll No. 112505600060 for the post of TGT Punjabi male, Post Code 56/21 of DSSSB Advertisement vide NO. 03/2021 dated 03.07.2021(cut off date) under SC category is hereby rejected/cancelled and his e-dossier returned to the DSSSB, GNCTD.
