ORDER

Cancellation of offer of Appointment and candidature to the post of PGT(ECONOMICS)
MALE, POST Code 66/20

Whereas, **Sh. PAWAN KUMAR, D.O.B. 01/04/1981, Roll No. 111906600019** has been nominated by the DSSSB to the post of PGT(ECONOMICS)-MALE against Post Code 66/20 vide Result Notice No.1419 dated 22/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.


And Whereas, **Sh. PAWAN KUMAR** was called for document verification vide memorandum letter no 548-549 dated 12th April 2022, on due course of document verification, it was found that the photograph available in e-dossier of the candidate didn't matched with the actual candidate who appeared for the document verification and thereafter the candidate never communicated with this office for substantiating his claim for the post of PGT (Economics) Male Post Code 66/20.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to **cancel** the candidature of **Sh. PAWAN KUMAR, D.O.B. 01/04/1981, Roll No. 111906600019, post PGT (ECONOMICS)-MALE** and return her dossier to the DSSSB.

Cancellation of offer of Appointment and candidature to the post of PGT(ECONOMICS)
MALE, POST Code 66/20

Whereas, **Sh. VIPUL KUMAR, D.O.B. 04/09/1991, Roll No. 121106600212** has been nominated by the DSSSB to the post of PGT(ECONOMICS)-MALE against Post Code 66/20 vide Result Notice No.1419 dated 22/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.

And Whereas, **Sh. VIPUL KUMAR** has given his declaration in writing via letter dated 17th Oct 2022 with the subject "Denial of offer of appointment for the post of PGT Economics (66/20)". where the candidate has stated that he has been working as PGT(Economics) in U.P. So, He is unable to join the post of PGT (Economics), Post Code 66/20 and requested to proceed ahead with cancellation of his candidature.
