ORDER

**Cancellation of offer of Appointment and candidature to the post of PGT(GEOGRAPHY)  
FEMALE, POST Code 78/20**

Whereas, **Ms. RITU, D.O.B. 01/10/1992, Roll No. 121107800232** has been nominated by the DSSSB to the post of PGT(GEOGRAPHY)-FEMALE against Post Code 78/20 vide Result Notice No.55 dated 02/12/2021 in the Directorate of Education, Govt. of NCT of Delhi.


And Whereas, **Ms. RITU** has given her declaration in writing via letter dated 10<sup>th</sup> Oct 2022 with the subject "For Cancellation of PGT-Geography Female Post Code 78/20 appointment". where the candidate has stated that her appointment for the post of PGT(Geography) Female post code 78/20 may be cancelled as she has been selected for the post of Assistant Professor in Jharkhand.

As per DOPT OM no. 35016/2/93-Estt.(D) dated 09.08.1995, the following has been mentioned:

*"An offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If however with the specified period a request is received from the candidate for extension of time, It may be considered by the Ministry/Department but extension beyond 3 months should not be granted liberally and it may be granted only as an exception where facts and circumstances so warrant and in any case only upto a maximum period of 6 months from the date of issue of original offer of an appointment". An offer of appointment would lapse automatically after the expiry of 6 months from the date of issue of the original offer of appointment.*

Therefore it is evident that the candidate is no longer interested in joining the above mentioned post. Hence, the Director (Education) being the Competent Authority ordered to cancel the candidature of **Ms. RITU, D.O.B. 01/10/1992, Roll No. 121107800232, post PGT (GEOGRAPHY)-FEMALE** and return her dossier to the DSSSB.
