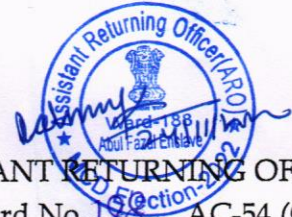

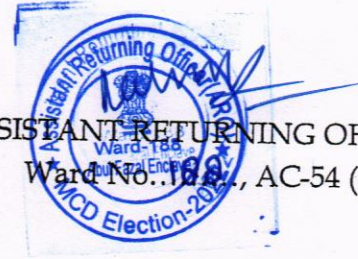

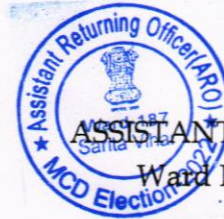

Now, therefore, it is hereby directed to show-cause why penal action should not be initiated against him/her for dereliction of duty and violation of provisions of Representation of Peoples Act, 1951. Either they should report to duty at the office of undersigned on 25-11-2022 by 10:00 AM failing which legal action as per Representation of Peoples act, 1951, and CCS/CCA Rules, will be initiated against him/her.
